ORDER DECLARING A RESTRICTED AREA AT EVERTON FOR THE CONTROL OF QUEENSLAND FRUIT FLY

I, Bob Cameron, Minister for Agriculture, under sections 20 and 22 of the **Plant Health and Plant Products Act 1995** make the following Order declaring a restricted area for the control of Queensland Fruit Fly and specifying the prohibitions, restrictions and requirements which are to operate in the restricted area.

1. Objective

The objective of this Order is to declare a restricted area for the control of Queensland Fruit Fly at Everton, and to specify the prohibitions, restrictions and requirements which are to operate in the restricted area.

2. Authorising provisions

This Order is made under sections 20 and 22 of the **Plant Health and Plant Products Act 1995**.

3. Definition

In this Order-

"Act" means the Plant Health and Plant Products Act 1995; and

"Queensland fruit fly" means the exotic pest Bactrocera tryoni (Froggatt); and

"Queensland fruit fly host material" means any fruit or vegetable listed as a host of Queensland fruit fly in Schedule 5 of the Plant Health and Plant Products Regulations 1996.

4. Restricted area for the control of Queensland fruit fly

The restricted area for the control of Queensland Fruit Fly is declared to be the area described in Schedule 1.

5. Prohibitions, restrictions and requirements

- (1) This order does not apply to Queensland fruit fly host material grown within the restricted area if accompanied by–
 - (a) an assurance certificate issued by a person who is accredited by the Department of Primary Industries; or
 - (b) a plant health certificate issued by an authorised inspector-

certifying that the Queensland fruit fly host material has been treated in a manner approved by the Manager Plant Standards.

- (2) The removal from the restricted area into any part of Victoria of any Queensland fruit fly host material is prohibited.
- (3) The owners and occupiers of land described in Schedule 2 must give access to such land at all times to an inspector, after 24 hours notice is given to the occupier or if the occupier consents to the entry, for the purpose of inspection, placing on such land any lures or traps, applying on such land any spray material or bait and performing any other actions in accordance with the Act which in the opinion of the inspector are necessary for the eradication or prevention of the spread of the pest.
- (4) The owners and occupiers of land described in Schedule 2, on instruction from an inspector, must strip Queensland Fruit Fly host materials from plants, collect and dispose of waste material, or treat the material in a manner approved by the Manager Plant Standards.

Schedule 1

The area of land bounded by a line commencing at the intersection of Petticoat Lane and Great Alpine Way, then heading in a straight line in a southerly direction to the intersection of Williams Lane and Cockrofts Lane, then in a southerly direction along Cockrofts Lane to the intersection of Cockrofts Lane and Oxley Flats Road, then in a straight line in a southerly direction to the intersection of Home Station Lane and Redferns Lane, then in a southerly direction along Redferns Lane, which becomes Oxley-Oxley Flats Road then Oxley-Meadow Creek Road, to the intersection of Oxley-Meadow Creek Road and Whorouly-Bobinawarrah Road, then in an easterly direction along Whorouly-Bobinawarrah Road to the intersection of Whorouly-Bobinawarrah Road and Milawa-Bobinawarrah Road, then in a southerly direction along Milawa-Bobinawarrah Road to the intersection of Milawa-Bobinawarrah Road and Docker-Carboor Road, then in an easterly direction along Docker-Carboor Road to the intersection of Docker-Carboor Road and Carboor-Everton Road, then in a southerly direction along Carboor-Everton Road to the intersection of Carboor-Everton Road and Fire Track No. 2, then in a straight line in an easterly direction to the intersection of Whorouly South Road and Carboor-Whorouly Road, then in a northerly direction along Carboor-Whorouly Road to the intersection of Carboor-Whorouly Road and Snow Road, then in an easterly direction along Snow Road to the intersection of Snow Road and Camp Lane, then in a straight line in a north-easterly direction to the intersection of Stoney Creek Road and Great Alpine Road, then in a north-westerly direction along Great Alpine Road to the intersection of Great Alpine Road and Buckland Gap Road, then in a northerly direction along Buckland Gap Road to the intersection of Buckland Gap Road and Bartsh Road, then in a westerly direction along Bartsh Road to the intersection of Bartsh Road and Diffey Road, then in a northerly direction along Diffey Road to the intersection of Diffey Road and Bridge Road, then in a westerly direction along Bridge Road, which becomes Beechworth-Wangaratta Road, to the intersection of Beechworth-Wangaratta Road and Flat Rock Road, then in a northerly direction along Flat Rock Road to the intersection of Flat Rock Road and Three Sisters Road, then in a straight line in a north-westerly direction to the intersection of Woolshed Road and Long Range Track, then in a straight line in a westerly direction to the intersection of Colin Angus Drive and Main Street, then in a north-westerly direction along Main Street, which becomes Wangaratta-Eldorado Road, to the intersection of Wangaratta-Eldorado Road and Petticoat Lane, then in a south-westerly direction along Petticoat Lane to the point of commencement.

Schedule 2

The area of land in Victoria within a radius of one and a half kilometres of the outbreak epicentre at 146.54317° East, 36.43497° South.

Order Declaring a Restricted Area at Wahgunyah for the control of Queensland fruit fly

I, Bob Cameron, Minister for Agriculture, extend the Order made on 8 April 2004 under sections 20 and 22 of the **Plant Health and Plant Products Act 1995** declaring a restricted area at Wahgunyah for the control of Queensland fruit fly, for a further period of 12 months commencing on 8 April 2006.

The Order was published in Government Gazette S86 on 8 April 2004, and extended by Order published in Government Gazette G13 on 31 March 2005, and specifies prohibitions, restrictions and requirements so as to prevent the spread of Queensland fruit fly from Wahgunyah to other parts of Victoria.
