#### Road Safety Act 1986

# EXEMPTION FROM ROAD RULE 270 FOR FILMING OF "ROMULUS MY FATHER"

I, Peter Batchelor, Minister for Transport, acting under section 99B(4) of the **Road Safety Act 1986** ("the Act") and on the application of Arenafilm Pty Ltd (ABN 83 003 242 519), declare that Road Rule 270 (wearing of approved motor bike helmets) does not apply to the non-road activities specified in column 1 of the Schedule conducted on the highways or parts of highways specified in column 2 of the Schedule during the periods specified in column 3 of the Schedule, subject to the following conditions:

- a. That a permit has been issued for the relevant non-road activities by the relevant road authority.
- b. That all vehicles, including trailers, used for the non-road activity are registered and any necessary permits required by the Road Safety (Vehicles) Regulations 1999 and the Road Rules Victoria are issued by the Roads Corporation.
- c. That any motorbike used for the non-road activity does not exceed a speed of 30 km/h.
- d. That the riders and passengers specified in column 1 of the Schedule wear protective skull caps as well as non-approved motor bike helmets.
- e. That all participants in the non-road activity comply with any directions issued by Victoria Police officers.
- f. That the parts of the highways used for the non-road activity are closed to traffic during the times when the activity is actually being carried out (which may not be the full period referred to in column 3 of the Schedule).
- g. That all safety requirements are complied with including (without limitation) all other provisions of the Act, the Road Rules Victoria, the Road Management Act 2004 and the Occupational Health and Safety Act 2004 and any regulations under those Acts.
