### NOTICE OF DECISION

#### Births, Deaths and Marriages Registration (Fees) Regulations 2006

I, John Thwaites, Minister for Victorian Communities and Minister responsible for administering the **Births, Deaths and Marriages Registration Act 1996**, give notice under section 12 of the **Subordinate Legislation Act 1994** as follows:

A Regulatory Impact Statement (RIS) was prepared in relation to the proposed Births, Deaths and Marriages Registration (Fees) Regulations 2006. The proposed Regulations provide for an amendment of the prescribed fees for the processing of:

- requests for certificates of birth, change of name, death or marriage;
- applications for registration of change of name; and
- request from customers for amendments to the Register.

The changes to the prescribed fees are intended to improve service delivery timeframes to customers whilst meeting quality and security requirements.

The RIS was advertised seeking public comment on 10 March 2006 and twenty-six submissions were received.

After considering the submissions, I have decided that the proposed Births, Deaths and Marriages Registration (Fees) Regulations 2006 should be made.
