#### **Road Safety Act 1986**

#### ROAD SAFETY (VEHICLES) REGULATIONS 1999

Notice declaring Certain Rearloader Waste Vehicles to be Class 3 Vehicles with Excess Rear Overhang

#### 1. Purpose

The purposes of this Notice are -

- a. to declare certain rearloader waste vehicles to be class 3 vehicles, and
- b. to specify a rear overhang limit.

#### 2. Authorising Provision

This Notice is made under -

- a. regulation 515 (2) of, and
- b. regulation 516 of, and
- c. clause 40 of Schedule 3 to –

the Road Safety (Vehicles) Regulations 1999 ("the Regulations").

#### 3. Commencement

This Notice comes into operation on the date of its publication in the Government Gazette.

#### 4. Revocation

The Notice published in Government Gazette No. S 162 of 24 August 2005, concerning the declaration of certain rear loader waste compactor vehicles is revoked.

#### 5. Expiration

This Notice expires on 30 April 2011.

#### 6. Declaration of rearloader waste compactor vehicles

In accordance with regulation 515 (2), I, Ted Vincent, delegate of the Roads Corporation, declare the following category of vehicles to be class 3 vehicles for the purposes of the Regulations:

- 3 axle rearloader waste vehicles fitted with a bin lifting mechanism and a tandem axle group with 8 tyres, where the bin lifting mechanism creates a rear overhang of
  - i. not more than 3.40 metres; and
  - ii. not more than 70% of the vehicle's wheelbase.

### 7. Specification of dimensions of rearloader waste vehicles

In accordance with regulation 516 and clause 40 of Schedule 3 of the Regulations, I, Ted Vincent, delegate of the Roads Corporation, specify the following dimension limits for the rear loader waste vehicles declared to be class 3 vehicles by clause 6 of this Notice:

- a. the rear overhang of the vehicle incorporating a bin lifting mechanism
  - i. must not exceed 3.40 metres, and
  - ii. must not exceed 70% of the vehicle's wheelbase; and
- b. Otherwise, the dimension limits are the relevant dimension limits set out in Division 2 of Part 4 of the Regulations.

## **SPECIAL**

### 8. Interpretation

In this Notice, unless the contrary intention appears, expressions used have the same meaning as in the **Road Safety Act 1986** and the Regulations. Nothing in this Notice authorises the driving of a vehicle in a manner or in a condition or place that is otherwise prohibited by the Regulations.
