## Subordinate Legislation Act 1994

### NOTICE OF PREPARATION OF REGULATORY IMPACT STATEMENT (RIS) Land Regulations 2006

Notice is given that, in accordance with section 11 of the **Subordinate Legislation Act 1994**, a Regulatory Impact Statement (RIS) has been prepared in relation to the Land Regulations 2006.

The objectives of the proposed Regulations are to –

- restrict the activities of the public on licensed water frontages; and
- prescribe fees and forms for the purposes of the **Land Act 1958**; and
- provide for the issue of duplicate documents; and
- provide for other matters for the purposes of the Act.

The RIS discusses possible alternatives to the proposed Regulations and concludes that the proposed Regulations are the best means of achieving the stated objectives.
