Notice of Approval of Amendment

#### Amendment C76

The Minister for Planning has approved Amendment C76 to the Casey Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment rezones part of the land at No. 1000 (known as Amstel Golf Club) plus Nos. 1020 and 1030 Cranbourne-Frankston Road, Cranbourne from a Rural Zone -Schedule 6 (RUZ6) to a Residential 1 Zone (R1Z), deletes the Development Contributions Plan Overlay - Schedule 1 (DCPO1) as it the land affects at No. 1030 Cranbourne-Frankston Road, Cranbourne, and applies a Development Plan Overlay (DPO12) over the subject land, to facilitate the residential development of the land.

The Minister has granted the following permit under Division 5 Part 4 of the Act:

Permit No.: P527/04.

Description of land: 1000 Cranbourne–Frankston Road (Lot 1 on Plan of Subdivision No. 431552E).
