Fair Trading Act 1999

INTERIM BAN ORDER PROHIBITING THE SUPPLY OF DANGEROUS GOODS AND REVOKING PREVIOUS ORDER IN RESPECT OF THE SAME GOODS

I, Marsha Thomson, Minister for Consumer Affairs, pursuant to the powers conferred on me by Part 3 Division 1 of the **Fair Trading Act 1999** hereby make an interim ban order ("the order") prohibiting the supply in Victoria of goods ("the goods"), as defined in Schedule 1 of the order, unless the goods comply with the conditions set out in Schedule 2 of this order. The order excludes goods referred to in Schedule 3.

Schedule 1

For the purposes of this order, "the goods" means babies' dummies that are used to pacify a baby and includes a teat which the baby sucks but from which the baby does not obtain fluid.

Schedule 2

Conditions

In this Schedule babies' dummies must comply with clauses 6, 7 and 8 of the Australian Standard AS 2432 - 1991.

Schedule 3

Exemptions

This order does not apply to babies' dummies that comply with the European Standard: EN 1400:2002 or the American Code of Federal Regulations Title 16, Part 1511.

I make this order under section 35(2) of the **Fair Trading Act 1999** on the recommendation of David Cousins, Director of Consumer Affairs Victoria, and because the goods appear to me to be dangerous.

Pursuant to the powers conderred on me by Part 3 Division 1 of the **Fair Trading Act 1999**, I hereby revoke the previous order dated 31 July 2006 and published in the Victoria Government Gazette No. S 192 of 2 August 2006 in respect of the goods mentioned in Schedule 1.

Explanatory Note

This interim order prohibits the supply of babies' dummies which do not comply with clauses 6, 7 and 8 of the Australian Standard AS 2432 – 1991 but does not include babies' dummies that comply with the European Standard: EN 1400:2002 or the American Code of Federal Regulations Title 16, Part 1511. This interim order revokes the previous order dated 31 July 2006 and published in the Victoria Government Gazette No. S 192 of 2 August 2006. The purpose of the interim order is to prevent a choking hazard which could lead to serious injury or death.
