### Marine Act 1988

#### **SECTION 15 NOTICE**

I, the Director of Marine Safety, on the recommendation of the Port of Melbourne Corporation, hereby give notice under subsection 15(1) of the **Marine Act 1988** of the following amendments to Notice No. 1 under section 15(2) of the **Marine Act 1988**:

#### 1. Amendments to Categorisation and Use of Waters

- (a) In Categorisation and Use of Waters, remove item 23B and substitute with "Vessels not to be Anchored in Channels
  - 23B. The operator, master or person in charge of a vessel must not allow a vessel to be anchored in a channel that is marked with beacons or buoys."
- (b) In Categorisation and Use of Waters, insert –


#### "Transit Zones

23D. The operator, master or person in charge of a vessel must not use a Transit Zone other than for transiting of the vessel and must not permit the vessel to be anchored in, or allow the vessel to drift in a Transit Zone."

## 2. Amendments to Schedule 1, Waters –The Designated Port of Port Phillip

### Waters - The Designated Port of Port Phillip

- (a) In Schedule 1, Item 6 delete sub-item (f);
- (b) In Schedule 1, insert
  - "7. Transit Zones for the purpose of clause 23C.
- (a) The waters of the Port of Port Phillip as delineated on Map 1 below –
