STRATHBOGIE PLANNING SCHEME

Notice of Approval of Amendment Amendment C34

The Minister for Planning has approved Amendment C34 to the Strathbogie Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment to the Strathbogie Planning Scheme applies a Public Acquisition Overlay (PAO1) to the land forming the proposed route of the Nagambie Bypass between south of Mitchellstown Road (south of Nagambie) to north of Goulburn Weir Road (north of Nagambie), together with other consequential changes to the scheme provisions. These include changes to the Schedule to the Public Acquisition Overlay to refer to the purpose as being road construction, and changes to the Schedule to Clause 52.17, to exempt VicRoads from the need to apply for a permit for native vegetation removal on affected land.
