## Project Development and Construction Management Act 1994

### SURRENDER AND DIVESTMENT OF LAND

#### Order in Council

The Governor in Council:

- (a) under section 18(1)(a) of the **Project Development and Construction Management Act 1994**, on the recommendation of the Minister for Major Projects and the recommendation of the Minister for Transport, given in accordance with section 18(6) of that Act, requires Victorian Rail Track (a public statutory authority established under section 8 of the **Rail Corporations Act 1996**) to surrender to the Crown the land described as Lot "2" on each of the Title Plans numbered 870254Y and 870256U and land described as Lot "2 (Pt)" on the Title Plan numbered 870255W, being Plans in the Schedule; and
- (b) under section 18(1)(b) of the **Project Development and Construction Management Act 1994**, on the recommendation of the Minister for Major Projects and the recommendation of the Minister for Transport, given in accordance with section 18(6) of that Act, divests from Victorian Rail Track the land described as Lot "A" on the Divestment Plan in the Schedule.

Paragraph (a) of this Order takes effect on the conveyance to the Crown or the registration of an instrument of transfer and surrender to the Crown of land that Victorian Rail Track is required to surrender under this Order.

Paragraph (b) of this Order takes effect on the publication of the Order in the Government Gazette.

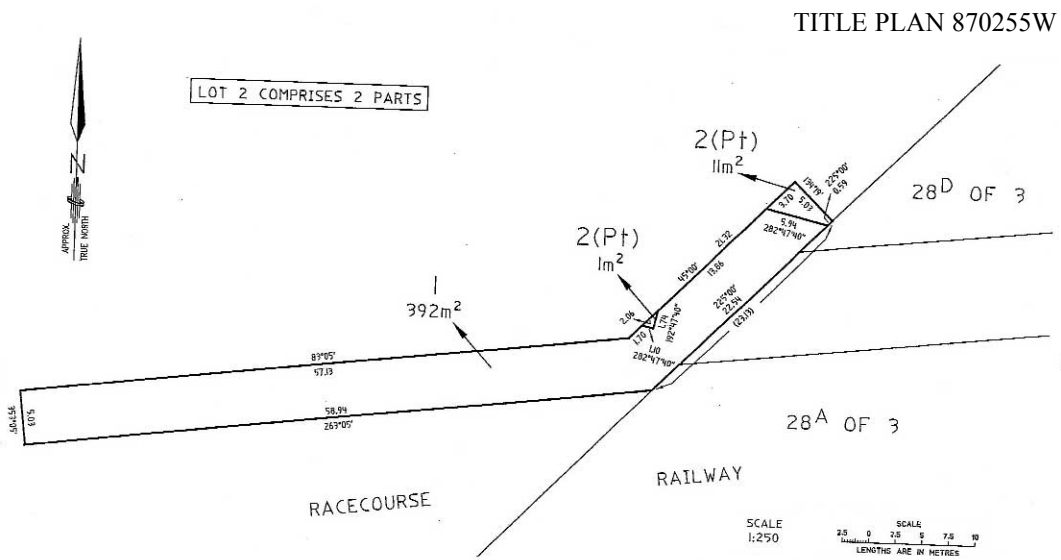
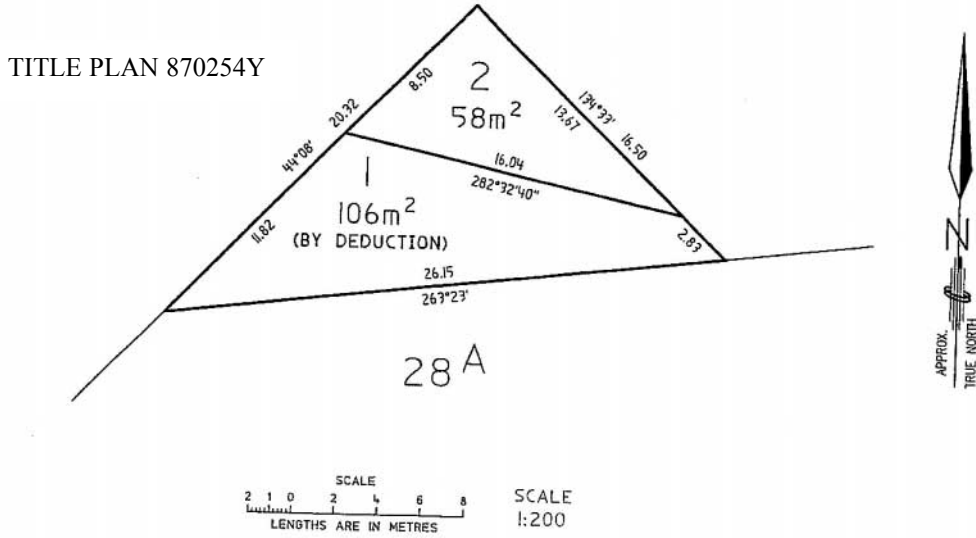
