#### **Notice of Amendment**

#### **Amendment C46**

The Minister for Planning has approved Amendment C46 to the Nillumbik Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment makes changes to Map Nos. 2HO, 3HO, 4HO, 6HO, 7HO, 9HO, 10HO, 11HO, 12HO, 13HO, 14HO, 15HO, introduces Map No. 16HO and modifies the Schedule to Clause 43.01 to include 73 sites that have been identified and recommended for heritage protection in the Nillumbik Shire Heritage Study Stage 2 (2001) and in the Heritage Assessments, Shire of Nillumbik Amendment C13 (2006) on an interim basis.
