Determination of Fees

I, Jim Betts, Director of Public Transport, Department of Infrastructure, pursuant to the provisions of section 147B of the **Transport Act 1983**, determine that the following fees shall apply from 1 February 2007 in respect of commercial passenger vehicle and private bus drivers' certificates, tow truck licences, accident towing driver authorities and commercial passenger vehicle licences other than the annual licence fees applicable to taxi-cab licences issued on or after 16 April 2003.
