## Road Management Act 2004


### ORDER PURSUANT TO CLAUSES 27 AND 28 OF SCHEDULE 5A

#### Order in Council

The Governor in Council, under clause 27 of Schedule 5A to the **Road Management Act 2004** (the Act), declares that all interests in the land located in the Redevelopment Project Area and identified as parcels 1 and 10 in the attached Survey Plan SP 21362 (the Subject Crown Land), are surrendered to the Crown.

Pursuant to clause 28(5) of Schedule 5A to the Act, this Order has the effect of reserving the Subject Crown Land for the purposes of the Link Upgrade Project.

Pursuant to clause 35 (I) of Schedule 5A to the Act, it is specified that the land identified as parcel 1 in the attached Survey Plan SP 21362 continues to be arterial road.



##### Order in Council

The Governor in Council, under clause 26(1)(b) of Schedule 5A to the **Road Management Act 2004** (the Act), divests the land, located in the Redevelopment Project Area and identified as parcels 7, 8, 9 and 12 in the attached Survey Plan SP 21362, from the City of Boroondara.

Pursuant to clause 28(5) of Schedule 5A to the Act, this Order has the effect of reserving the Subject Land for the purposes of the Link Upgrade Project.
