## Subordinate Legislation Act 1994

### NOTICE OF PREPARATION OF REGULATORY IMPACT STATEMENT Legal Profession (Practising Certificate Fees) Regulations 2007

Notice is given in accordance with section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared to assess the impact of the proposed regulations.

#### Reason for and objectives of proposed statutory rule

A practising certificate is required under the **Legal Profession Act 2004** for a person to be a legal practitioner in Victoria. The Act requires that an application for a practising certificate be accompanied by the prescribed fee for the certificate. The proposed Regulations set the prescribed fee from 1 July 2008 until 30 June 2011.

The RIS assesses the costs and benefits of various alternatives and explains why the proposed Regulations are the preferred solution.

#### Summary of results of RIS

The RIS has concluded that the fees should be set to reflect the impact of CPI since the fees were last set in 1997.

The proposed Regulations will increase fees for practising certificates from 1 July 2008:

- from \$320 to \$412 for practitioners authorised to receive trust monies; and
- from \$200 to \$256 for practitioners not authorised to receive trust monies.
