## Marine Act 1988

### SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Stuart Ord, Regional Manager, City and Bays, Parks Victoria, hereby give notice under subsection 15(1) of the **Marine Act 1988** that from 8.00 am on Saturday 24 December 2007 until 2.00 pm on Saturday 24 December 2007, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the event and vessels owned and operated by Parks Victoria are prohibited on the waters of the Yarra River between an imaginary line joining the downstream edge of the VRA Landing to the upstream edge of Federation Wharf and the Bridge Road Bridge.

## Marine Act 1988

### SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Timothy Tully, Senior Sergeant, Victoria Police, hereby give notice under subsection 15(2) of the **Marine Act 1988** that the following definition be inserted into Clause 1 of Notice 1 made under subsection 15(2) of the **Marine Act 1988**.

“Search and rescue operation” includes –

- (a) formal training; and
- (b) any activity or function incidental to the provision of search and rescue services

conducted under a safety Management Plan approved by Marine Safety Victoria.
