NOTICE OF DECISION

Transport (Taxi-Cab Industry Accreditation) Regulations 2007

I, Lynne Kosky, Minister for Public Transport and Minister responsible for administering the **Transport Act 1983**, give notice under section 12 of the **Subordinate Legislation Act 1994** of my decision to recommend to the Governor in Council that the proposed Transport (Taxi-Cab Industry Accreditation) Regulations 2007 be made.

The objective of the proposed Regulations is to –

- facilitate the provision of safe, reliable and efficient taxi-cab services that meet reasonable community expectations by prescribing –
 - (a) evidence and other things that must accompany an application for accreditation;
 - (b) conditions to which accreditations are subject relating to the keeping of records, the submission of information to the licensing authority and the inspection and auditing of records; and
- make consequential and related amendments to the Transport (Taxi-Cabs) Regulations 2005.

A Regulatory Impact Statement (RIS) was prepared in relation to the proposed Transport (Taxi-Cab Industry Accreditation) Regulations 2007. The RIS was advertised on 24 October 2007 seeking public comment and 10 submissions were received. After considering the submissions received, I have decided that the proposed Regulations should be made with amendments.
