## Liquor Control Reform Act 1998


### SECTION 147 – ORDER DECLARING DESIGNATED AREA

I, Susan Maclellan, Director of Liquor Licensing, pursuant to section 147 of the **Liquor Control Reform Act 1998** (the Act), declare the following area to be a designated area for the purposes of Part 8A of the Act:

#### Melbourne and Surrounding Suburbs

The area of Melbourne and surrounding suburbs bounded by the northern boundary of La Trobe Street, Melbourne commencing at the intersection of Spencer Street, Melbourne in an easterly direction to the intersection of Victoria and Spring Streets Street, Melbourne, then the eastern boundary of Spring Street, Melbourne in a southerly direction to the intersection of Flinders Street, Melbourne, then the southern boundary of Flinders Street, Melbourne in a westerly direction to the intersection of Batman Avenue, Melbourne, then the eastern boundary of Batman Avenue, Melbourne in a southerly direction to the intersection of Olympic Boulevard (Swan Street) and the Swan Street Bridge, Melbourne, then the southern boundary of the Swan Street Bridge in a westerly direction to the intersection of Alexandra Avenue, Melbourne, then the southern boundary of Alexandra Avenue, Melbourne in a north-westerly direction to the intersection of St Kilda Road, Melbourne, then the southern boundary of City Road (Yarra Bank Highway), Southbank in a south-westerly direction to the intersection of Clarendon Street, Southbank, then the western boundary of Clarendon Street, Southbank in a northerly direction to the intersection of Normanby Road, Southbank, then the southern boundary of Normanby Road, Southbank/South Melbourne in a westerly direction to the intersection of Montague Street, Southbank/South Melbourne, then the western boundary of Montague Street, Southbank/South Melbourne in a north-westerly direction to Charles Grimes Bridge Road (Docklands Highway), Melbourne/Docklands, then the western boundary of Charles Grimes Bridge Road (Docklands Highway), Melbourne/Docklands in a northerly direction to Wurundjeri Way, Melbourne/Docklands, then the northern boundary of Wurundjeri Way, Melbourne/Docklands in a north-easterly direction to the intersection of Flinders Street, Melbourne, then the northern boundary of Flinders Street, Melbourne in an easterly direction to the intersection of Spencer Street, Melbourne, then the western boundary of Spencer Street, Melbourne in a northerly direction to the intersection of La Trobe Street, Melbourne as shown in the following plan:



SECTION 147 – ORDER DECLARING DESIGNATED AREA

I, Susan Maclellan, Director of Liquor Licensing, pursuant to section 147 of the **Liquor Control Reform Act 1998** (the Act), declare the following area to be a designated area for the purposes of Part 8A of the Act:

South Yarra and Prahran

The area of South Yarra and Prahran bounded by the northern boundary of Toorak Road, South Yarra commencing at the intersection of Osborne Street, South Yarra in an easterly direction to the intersection of Cromwell Road, South Yarra, then the eastern boundary of Cromwell Road, South Yarra in a southerly direction to the intersection of Surrey Road, South Yarra, then the eastern boundary of Surrey Road, South Yarra in a southerly direction to the intersection of Malvern Road, South Yarra/Prahran, then the northern boundary of Malvern Road, South Yarra/Prahran in an easterly direction to the intersection of York Street, Prahran, then the eastern boundary of York Street, Prahran in a southerly direction to the intersection of High Street, Prahran, then the southern boundary of High Street, Prahran in a westerly direction to the intersection of Charles Street, Prahran, then the western boundary of Charles Street, Prahran in a northerly direction to the intersection of Commercial Road, Prahran/South Yarra, then the northern boundary of Commercial Road, Prahran/South Yarra in an easterly direction to the intersection of Osborne Street, South Yarra, then the western boundary of Osborne Street, South Yarra in a northerly direction to the intersection of Toorak Road, South Yarra as shown in the following plan:
