- a) That part of Western Freeway identified by hatching on the plan numbered GP31FW is declared as described in the legend in the said plan.






- b) That part of Gisborne–Melbourne Road identified by hatching on the plan numbered GP11498 is declared as described in the legend in the said plan.

- f) That part of Rosedale–Heyfield Road identified by hatching on the plan numbered GP20718 is declared as described in the legend in the said plan.



