Fair Trading Act 1999

ORDER PROHIBITING THE SUPPLY OF DANGEROUS GOODS AND REVOKING PREVIOUS ORDER

I, Tony Robinson, Minister for Consumer Affairs, pursuant to the powers conferred on me by Part 3 Division 1 of the **Fair Trading Act 1999** hereby make an order prohibiting the supply in Victoria of goods of the kind specified in Schedule 1.

I make this order noting that the supply of the goods the subject of this order has been permanently prohibited pursuant to section 30(1)(a) of the **Fair Trading Act 1987** of the State of New South Wales, published in the New South Wales Gazette No.185 part 2 of 21 December 2007, thereby satisfying the requirements of section 40(1) and 40(2) (b) of the **Fair Trading Act 1999** (Vic).

Pursuant to the powers conferred on me by Part 3 Division 1 of the **Fair Trading Act 1999** I hereby revoke the previous order prohibiting the supply of goods of the kind specified in Schedule 2, made on 7 November 2007 and published in the Victoria Government Gazette No. S281, of 7 November 2007.

Schedule 1

Bead toys, including 'Bindeez' bead toys, containing 1,4-Butanediol.

Schedule 2

'Bindeez' bead toys which are little beads that join with a spray of water.

Explanatory Note

This permanent ban order prohibits the supply of bead toys, including 'Bindeez' bead toys, containing 1,4-Butanediol, which if ingested may lead to symptoms including drowsiness, reduced levels of consciousness and fits or seizures.
