## SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Senior Sergeant Rex Brown, a member of Victoria Police, hereby give notice under sub-section 15(2) of the **Marine Act 1988** of the following amendments to Notice No. 1 under section 15(2) of the **Marine Act 1988**:

1. revoke the rules regulating the operation of vessels on the waters of Lake Colac set out in Schedule 146 of the Notice No. 1 made under section 15(2) of the **Marine Act 1988**; and
2. give notice of the following rules regulating the operation of vessels on the waters of Lake Colac:

### SCHEDULE 146

#### WATERS – LAKE COLAC

##### *Local Authority – State Waters*

1. 5 knot zone for the purposes of Clause 7

The whole of the waters of Lake Colac are subject to a speed restriction of 5 knots.

2. Area prohibited to vessels for the purposes of Clause 9.

The waters of Lake Colac extending approximately 1,830 metres from the waters edge between two lines of red markers in the water installed and maintained by the Colac Rifle Club, each line commencing from a sign on the shore adjacent to Rifle Butt Road and Deans Creek respectively, are prohibited to vessels on Saturdays between midday and 6 pm.

## SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Stuart Ord, Regional Manager City and Bays, Parks Victoria, hereby give notice under sub-section 15(1) of the **Marine Act 1988** that bathing and the operation of vessels are prohibited on the waters of the Yarra River between the VRA Judges Box and Ships Box (Birraring Marr) between the hours of 10.00 am and 11.00 am on Thursday 15 February 2007 excluding vessels owned and operated by Parks Victoria.
