#### **Notice of Approval of Amendment**

#### **Amendment C53**

The Minister for Planning has approved Amendment C53 to the Campaspe Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment rezones Lot 1 Channel Road, Colbinabbin (Lot 1 on Title Plan 097062T) from Rural Zone (RUZ) to Public Use Zone 1 – Service and Utility (PUZ1), deletes the Public Acquisition Overlay (PAO3), amends the schedule to Clause 45.01 to remove reference to the PAO map and amends the schedule to Clause 61.03 to remove reference to the PAO map within the Campaspe Planning Scheme.
