The Secretary to the Department for Victorian Communities ("the Secretary"), a body corporate created under section 41A of the **Swimming Championships Act 2004** ("the WCS Act") hereby declares that the classes of persons set out in Column 1 are authorised under section 88 for the activities listed in Column 2 in the area set out in Column 3, during the Championship period.

Also the designated access areas outside of the Melbourne Park and the Melbourne Sports and Aquatic Centre fenced venues.

Terms and Conditions to which the authorisation is subject: This authorisation is given upon and is subject to the lawful directions given by members of the Victoria Police Force or the Australian Federal Police as well as any other terms and conditions imposed by the Secretary or M2007, or each or any of them, as the case may be.

The Secretary to the Department for Victorian Communities ("the Secretary"), a body corporate created under section 41A of the **Swimming Championships Act 2004** ("the WSC Act") hereby declares that the following classes of persons set out in Column 1 are authorised under section 88 to possess and bring the prohibited items in Column 2 into the declared areas in Column 3.

Bicycles, scooters, roller skates, rollerblades and skateboards on the condition the owner dismounts as directed by authorised officers and walks the bicycle, scooter or carries the roller skates, rollerblades or skateboard through the area.	ZONE 1a, ZONE 2 and ZONE 4 of the designated access areas associated with St Kilda Beach. Also the designated access areas outside of the Melbourne Park and Melbourne Sports and Aquatic Centre fenced venues.
The general public.	Dogs on the condition that dog litter is immediately removed by the owner/ guardian of the dog.	ZONE 1a, ZONE 2 and ZONE 4 of the designated access areas associated with St Kilda Beach. Also the designated access areas outside of the Melbourne Park and Melbourne Sports and Aquatic Centre fenced venues.
Athletes and/ or officials who are accredited by the Corporation to enter Championship venues and designated access areas.	Carrying flags of nations that exceed 1 metre x 1 metre into a Championship venue or designated access area.	All Championship venues and designated access areas as declared under the Act.
