### Safety on Public Land Act 2004

#### AMENDMENT TO DECLARATIONS OF PUBLIC SAFETY ZONES

I, Janine Haddow, Executive Director of Land and Natural Resources, as delegate of the Secretary of the Department of Sustainability and Environment, amend the following declarations of public safety zones made under section 4(1) of the **Safety on Public Land Act 2004**:

### Safety on Public Land Act 2004

### **DECLARATION OF PUBLIC SAFETY ZONES**

I, Janine Haddow, Executive Director of Land and Natural Resources, as delegate of the Secretary of the Department of Sustainability and Environment, make the following declaration of public safety zones under section 4(1) of the **Safety on Public Land Act 2004**.

#### Areas:

1. The area of State forest contained within the following location coordinates is declared to be a public safety zone.

- 2. The extent of the public safety zone is described by the minimum planimetric extent using a North South orientated rectangle that encloses the area bound by:
  - (a) the south-west limit described by the first two metric coordinates (Easting and Northing); and
  - (b) the north-east limit described by the next two metric coordinates (Easting and Northing).
- 3 The public safety zone is limited to all areas that contain State forest within an area identified by the above coordinates.
- 4. The coordinates in Column 1 are provided in Map Grid of Australia (MGA) Universal Transverse Mercator (UTM) Zone number 55 or 54. These use the Geodetic Reference System 1980 (GRS80) spheroid.

### **Purpose:**

5. The purpose for which the areas have been declared public safety zones is for the purpose of timber harvesting operations and the maintenance of public safety.

#### Period of the declaration:

6. The period for which these areas are public safety zones is the period from the date of gazettal of this declaration to 30 June 2007 inclusive.

### Activities permitted, prohibited or restricted:

7. Within a public safely zone a person shall not undertake any activity that interferes with the activities of a person to whom an exemption under this Declaration or section 9 of the **Safety on Public Land Act 2004** applies.

### Periods when access is restricted/prohibited:

8. Subject to clause 7 and 10 of this declaration, access to the public safety zones is prohibited at all times.

### Further restrictions or conditions (if any):

9. There are no further restrictions or conditions applying to the public safety zones.

### Exempt persons or classes of person

- 10. Pursuant to section 5(2) of the **Safety on Public Land Act 2004** the following persons or classes of person are exempted from the operation of this public safety zone declaration:
  - a) Persons undertaking timber harvesting operations which are authorised operations within the meaning of section 45 of the **Sustainable Forests (Timber) Act 2004** including:
    - (i) VicForests and its employees, agents and contractors;
    - (ii) persons who have an agreement with VicForests to harvest or sell timber resources and their employees, agents and contractors;
    - (iii) holders of licences or permits under section 52 of the **Forests Act 1958** and their employees, agents and contractors.
  - b) Persons undertaking timber harvesting operations in accordance with an approved Plan of Utilization as defined in the **Forests (Wood Pulp Agreement) Act 1996**.
  - c) Holders of licences or permits under section 52 of the **Forests Act 1958** granted by the Secretary to thin, cut and remove timber, to cut forest produce specified in the licence, to dig forest produce specified in the licence or to take away forest produce specified in the licence and their employees, agents and contractors.
  - d) Holders of Bee Farm licences, Bee Range area Licences, Apiary Occupation Rights under Subdivision 2 of Division 9, of Part 1 of the **Land Act 1958**, granted by the Minister on Crown Land.
  - d) Employees, agents and contractors of the Department of Sustainability and Environment engaged in carrying out their functions.
  - e) Employees, agents and contractors of the Country Fire Authority, WorkSafe, Environment Protection Authority and the State Emergency Services engaged in carrying out their functions.
  - f) Members of the police force of Victoria engaged in carrying out their functions.
  - g) Persons appointed as environmental auditors under the **Environment Protection Act 1970** and their agents in carrying out their functions as forestry auditors.
  - h) Persons who have been selected by the Environment Protection Authority to act as audit observers and who are participating in this activity exclusively. Audit observers must be in the company of an EPA employee or an environmental auditor appointed under the **Environment Protection Act 1970** and their agents in carrying out their functions as forestry auditors.
  - i) Holders of leases, licences, permits or other authorities (and associated employees, agents and contractors) under the Mineral Resources Development Act 1990, Extractive Industries Development Act 1995 and Petroleum Act 1998, other than holders of miners' rights and tourist fossicking authorities under the Mineral

Resources Development Act 1990, whilst undertaking works associated with that lease, licence, permit or authority in the areas covered by the declaration provided that:

- (i) those works do not interfere with or hinder timber harvesting operations;
- (ii) those classes of person have made prior arrangements with the forest manager to be in the area for the purpose of undertaking those works;
- (iii) those classes of person abide by the Occupational, Health & Safety requirements established by the Department of Sustainability and Environment, VicForests or the contractor in charge of the site.

- 2. In addition to the above persons or classes of person exempted under section 5(2), section 9 of the **Safety on Public Land Act 2004** provides that a public safety zone declaration does not apply to the following:
  - the Secretary;
  - an authorised officer;
  - a utility engaged in the carrying out of its functions in a State forest;
  - a transport authority engaged in the carrying out of its functions in a State forest;
  - a person or class of person authorised under section 10 to be in the public safety zone.

#### Sustainable Forests (Timber) Act 2004

### ALLOCATION TO VICFORESTS ORDER - 2007 AMENDMENT

I, John Thwaites, Minister for Water, Environment and Climate Change, make the following order to amend the **Allocation to VicForests Order 2004**.

#### 1 Title

This order may be cited as the Allocation to VicForests (Amendment) Order 2007.

#### 2. Objectives

The objective of this order is to amend the Allocation to VicForests Order 2004 (the 2004 order) to implement changes which derive from a review of the allocation of timber resources conducted under section 18 of the **Sustainable Forests (Timber) Act 2004** as a result of fire in 2003 and 2006/7 and other events and matters which have a significant impact on timber resources in State forests.

### 3. Authorising provision

This amendment is made under section 17 of the Sustainable Forests (Timber) Act 2004.

#### 4. Amendments

For paragraph 4 of the 2004 order substitute the following:

"VicForests is allocated timber in the forest stands described in Tables 1–3 of this Order and has access to those stands for the purposes of harvesting and selling timber resources. The map at Attachment 1 shows the Forest Management Areas in which the forest stands that can be accessed by VicForests under this Order are located.

These forest stands, including those affected by fire in 2003 and 2006/07, are made available to VicForests for timber harvesting. In accordance with section 12 of the **Sustainable Forests** (**Timber**) **Act 2004**, VicForests are required to demonstrate that timber harvesting, including salvage, and other operations will be conducted in accordance with the Sustainability Charter, and in such a way to minimise the impact of the 2006/07 fires on the long-term environmental, social and economic values of State forest.

Approval of coupes within the fire affected area for the purposes of fire salvage harvesting will be subject to an assessment of the extent and severity of fire damage.

The maximum area (in hectares) of each forest stand that can be harvested for timber in the 15-year time frame of this Order is divided into three 5-year periods. Forest stands not harvested in the 5-year period identified in Tables 1–3 may be harvested in a subsequent 5-year period, unless a review of this Order specifies otherwise.

Table 1 sets out the maximum area that can be harvested in the first five-year period, including fire salvage. Table 2 and Table 3 define an area of forest available for harvesting in the second and third five-year periods after allowing for the impact of fires in 2006/07. Allocations made for the second and third five-year periods have been made using the best available data but are only indicative.

VicForests is also allocated timber in the forest stands described in tables 4–6 of this Order and has access to those stands for the purposes of thinning and selling timber resources.

The maximum area (in hectares) of each forest stand that can be thinned in the 15-year time frame of this Order is divided into three 5-year periods. Table 4 sets out the maximum area that can be thinned in the first five-year period, Table 5 sets out the maximum area that can be thinned in the second five-year period and Table 6 sets out the maximum area that can be thinned in the third five-year period.

The map at Attachment 1 shows the Forest Management Areas in which the forest stands that can be accessed by VicForests under this Order are located.

Timber allocated under this Order excludes the pulpwood obtained from forest stands which is required to meet supply commitments specified in the Forests (Wood Pulp Agreement) Act 1996.

In accordance with section 18(1) of the **Sustainable Forests (Timber) Act 2004**, a review of the Allocation Order will be completed prior to 30 June 2009. The 2009 review will determine future resource allocations for VicForests, taking into consideration the extent and severity of fire damage caused in 2006/07."

Insert the following paragraph into paragraph 5 of the 2004 order:

"VicForests are permitted to harvest wattle (*Acacia spp.*) where these occur in conjunction with allocated forest stands identified in Tables 1–6."

In paragraph 6 of the 2004 order:

Insert reference to the following document as the first dot point:

"The Sustainability Charter, 2006. Department of Sustainability and Environment".

Substitute for the document referred to as "The Code of Practice for Fire Management on Public Land 1995. Department of Conservation and Natural Resources" reference to the following document: "The Code of Practice for Fire Management on Public Land, Revision No. 1 2006. Department of Sustainability and Environment".


Substitute for the document referred to as "The Management Procedures for timber Harvesting and Associated Activities in State Forests in Victoria 2004. Department of Sustainability and Environment" reference to the following document: "The Management Procedures for Timber Harvesting and Associated Activities in State Forests in Victoria 2005. Department of Sustainability and Environment".

Substitute for the document referred to as "The Utilisation Procedures for all Commercial Harvesting in State Forests in Victoria, 2001. Department of Natural Resources and Environment" reference to the following document: "Salvage Harvesting Prescriptions 2007. Department of Sustainability and Environment".

For Tables 1, 2 and 3 of the 2004 Order substitute the attached tables 1, 2 and 3.

For note 1 to all tables substitute the following note:

"The extent and location of forest stands to which VicForests has access have been amended to incorporate the effects of 2006/07 fires and to allow timber harvesting of fire affected stands to occur. Future resource allocations will be reviewed by 30 June 2009 and will be based on detailed analysis and modelling incorporating fire severity mapping."
