Marine Act 1988

SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Stuart Ord, Regional Manager, City and Bays, Parks Victoria, hereby give notice under subsection 15(1) of the **Marine Act 1988** that:

- (1) Bathing and the operation of vessels are prohibited on the waters of Victoria Harbour within the area detailed in Table 1 at the times as specified in Table 2, excluding those persons and vessels detailed below, vessels owned and operated by Parks Victoria, and vessels and persons involved with the events.
- (3) The vessels involved with the Wakeboard Australia National Championships are excluded from Clauses 7(1), 14 and of Notice No.1 made under Section 15(2) of the **Marine Act 1988** for the times detailed in Table 2.
- (4) At the completion of the event specified above, and as determined and announced by the Parks Victoria Ranger in Charge – Yarra River, the waters will revert to the provisions of Schedule 3 contained in Notice No.1 made under subsection 15(2) of the **Marine Act 1988**.

- (c) A line extending from a marker buoy located in approximate position 37° 49' 0.328152" S 144° 56' 28.44492" E to a marker buoy in approximate position 37° 49' 7.438152" S 144° 56' 28.44492" E;
- (d) A line extending from a marker buoy located in approximate position 37° 49' 7.438152" S 144° 56' 28.44492" E to a marker buoy in approximate position 37° 49' 5.69118" S 144° 56' 8.94552" E.

**Marine Act 1988****SECTION 15 NOTICE**

I, the Director of Marine Safety, on the recommendation of Stuart Ord, Regional Manager, City and Bays, Parks Victoria, hereby give notice under subsection 15(1) of the **Marine Act 1988** that for the periods and locations outlined below, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding those vessels involved with the 2007 Melbourne International Dragon Boat Festival, are prohibited on the following waters of the Yarra River:

- (a) The waters of Victoria Harbour within the area detailed in Table 1 from 8.00 a.m. to 6.00 p.m. on 11 March 2007.
