PROPOSED DRUGS. POISONS AND CONTROLLED SUBSTANCES (HEALTH PROFESSIONS AMENDMENT) REGULATIONS 2007

Preparation of Regulatory Impact Statement

Notice is given in accordance with Section 11 of the Subordinate Legislation Act 1994 that a Regulatory Impact Statement has been prepared in connection with the proposed Drugs, Poisons and Controlled Substances (Health Professions Amendment) Regulations 2007.

The proposed Drugs, Poisons and Controlled Substances (Health Professions Amendment) Regulations 2007 amend the Drugs, Poisons and Controlled Substances Regulations 2006 to create a new category of 'authorised podiatrist' who would be authorised to use, sell or supply certain Scheduled Poisons.

The Regulatory Impact Statement assesses the costs and benefits of the proposed regulations and other practicable means of achieving the same objectives. The Regulatory Impact Statement concludes that the benefits of the proposed regulations outweigh the likely costs.
