### NOTICE OF DECLARATION OF PROJECT UNDER SECTION 201F

I, Justin Madden, Minister for Planning,  
by this notice declare the Otway Basin Carbon  
Capture and Storage Project to be a development  
of State significance.

In this notice, the “Otway Basin Carbon  
Capture and Storage Project” means the  
extraction of predominantly carbon dioxide from  
the Buttress Warre “C” reservoir via the Buttress  
1 well, processing at a small plant, transport via a  
pipeline approximately two kilometres in length  
and injection through the CRC-1 well into the  
Naylor 1/CRC 1 Warre “C” reservoir located  
approximately two kilometres below the ground  
at Nirranda, and all associated construction  
operation and monitoring activities.
