REGULATORY IMPACT STATEMENT

Gambling Regulation (Sports Betting Fees) (Amendment) Regulations 2007

Notice is given that, in accordance with section 11 of the **Subordinate Legislation Act 1994**, a Regulatory Impact Statement (RIS) has been prepared in relation to the Gambling Regulation (Sports Betting Fees) (Amendment) Regulations 2007.

The proposed Regulations prescribe fees payable to the Victorian Commission for Gambling Regulation (VCGR) under the **Gambling Regulation Act 2003** for applications for approval as a sports controlling body, for a determination of an agreement between sports betting provider and sports controlling body and a variation or revocation of a determination. The objective of the proposed Regulations is to set the fee for recovery of costs by the VCGR.

The RIS considers possible alternatives to the proposed Regulations and concludes that the proposed Regulations are the best means of achieving the stated objectives.
