Preparation of Regulatory Impact Statement

Notice is given in accordance with section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement has been prepared in connection with the proposed Radiation Regulations 2007.

The proposed regulations are to be made under Section 139 of the **Radiation Act 2005**.

The objective of the proposed regulations is to:

- prescribe the activity concentration and activity of material that spontaneously emits ionising radiation and the prescribed circumstances for the purposes of the definition of radioactive material;
- prescribe radiation dose limits;
- prescribe the radiation sources that require a current certificate of compliance prior to use of the source;
- prescribe the date of expiry for certificates of compliance issued in respect of prescribed radiation sources;
- exempt for a limited time certain radiation sources from the need to have a certificate of compliance;
- prescribe fees; and
- prescribe other matters required to give effect to the Act.

The Regulatory Impact Statement assesses the costs and benefits of the proposed regulations and concludes that the benefits of the proposed regulations outweigh the likely costs.
