## Livestock Disease Control Act 1994

### ORDER DECLARING AN OUTBREAK OF EQUINE INFLUENZA

I, Hugh Millar, Chief Veterinary Officer, acting as delegate of the Secretary of the Department of Primary Industries under section 105 of the **Livestock Disease Control Act 1994**, hereby certify that an outbreak of the exotic disease Equine Influenza exists on a property at Eastern Creek in New South Wales and it is necessary or expedient to take action or to make authorisation or declaration under this Act to prevent, or reduce the risk of, the spread of the disease in Victoria.

\* Note

Section 105(2) of the **Livestock Disease Control Act 1994** provides that, when an order of this kind has been made, no proceedings for an injunction, or for any order in the nature of a prerogative writ or of any other kind may be instituted or continued in any court against the Minister, the Secretary, an Inspector or any other person that would stop, prevent or restrain the Minister, Secretary, Inspector or other persons from taking or purporting to take any action or making any declaration or authorisation under this Act in relation to or in consequence of an outbreak or suspected outbreak of Equine Influenza (whether within Victoria or any other part or area of Australia).

### NOTICE OF ORDER

#### Order Declaring a Control Area for Equine Influenza

I, Joe Helper, Minister for Agriculture, give notice of the making of an Order under section 29 of the **Livestock Disease Control Act 1994**, declaring an area being the State of Victoria to be a Control Area for the exotic disease Equine Influenza; specifying the prohibitions, restrictions and requirements which are to operate in the Control Area and identifying the livestock that are affected by the Order.

The Order has effect for three days.

### APPOINTMENT OF INSPECTORS

These appointments remain in force until revoked or until the Order made under section 105 of the **Livestock Disease Control Act 1994**, declaring an outbreak of Equine Influenza, is revoked.
