FISHERIES (PREMIER LAKES) NOTICE NO. 9/2007

- 1. Title**

This Notice may be cited as the Fisheries (Premier Lakes) Notice No. 9/2007.
- 2. Objective**

The objective of this Notice is to equitably share salmonids that are stocked into Premier Lakes by setting a daily catch limit for salmonids.
- 3. Authorising Provision**

This Notice is made under sections 68A and 152 of the **Fisheries Act 1995** ('the Act').
- 4. Commencement**

This Notice comes into operation on 20 September 2007.
- 5. Definitions**

In this Notice –
'daily bag limit' means the maximum number or other specified quantity of fish or fishing bait that may be taken by a person in 1 day.
- 6. Prohibition**

For the purposes of section 68A of the Act, the daily bag limit and possession limit with respect to the taking or possession of salmonids in, on or next to: –

 - (i) Hyland Lake;
 - (ii) Jubille Lake;
 - (iii) Kennington Reservoir;
 - (iv) Lillydale Lake

is 2 salmonids.
- 7. Revocation**

Unless sooner revoked, this Fisheries Notice will be automatically revoked 12 months after the day on which it comes into operation.
