REVOCATION OF ORDER DECLARING PARKS VICTORIA AS A LOCAL AUTHORITY IN RESPECT OF SPECIFIED STATE WATERS

I, Tim Pallas, Minister for Roads and Ports,
make the following order:

Acting under section 3(3A) of the **Marine Act 1988** and all other enabling powers, I revoke the Order made under section 3(3)(b) of the **Marine Act 1988**, dated 2 July 1998 and published in the Government Gazette S69 on 3 July 1998, declaring Parks Victoria to be a local authority in respect of the State waters specified in the Order. This revocation also effectively revokes any powers conferred on Parks Victoria by operation of s157 of the **Marine Act 1988**.

This revocation comes into effect at 12.01 am on Wednesday 12 September 2007.

ORDER DECLARING PARKS VICTORIA TO BE THE WATERWAY MANAGER OF SPECIFIED STATE WATERS

I, Tim Pallas, Minister for Roads and Ports,
make the following order:

Acting under section 3(3)(b) of the **Marine Act 1988** and all other enabling powers, I declare Parks Victoria to be the waterway manager of the following State waters:

Local port of Port Phillip excluding port of Melbourne waters and the port waters of the port of Geelong.

Local port of Western Port.

Yarra River east of a line connecting Points 22 and 23 delineated on the plan numbered LEGL./00-09 lodged in the Central Plan Office of the Department of Sustainability and Environment.

Maribyrnong River north of a line connecting points 18 and 19 delineated on the plan numbered LEGL./00-09 lodged in the Central Plan Office of the Department of Sustainability and Environment.
