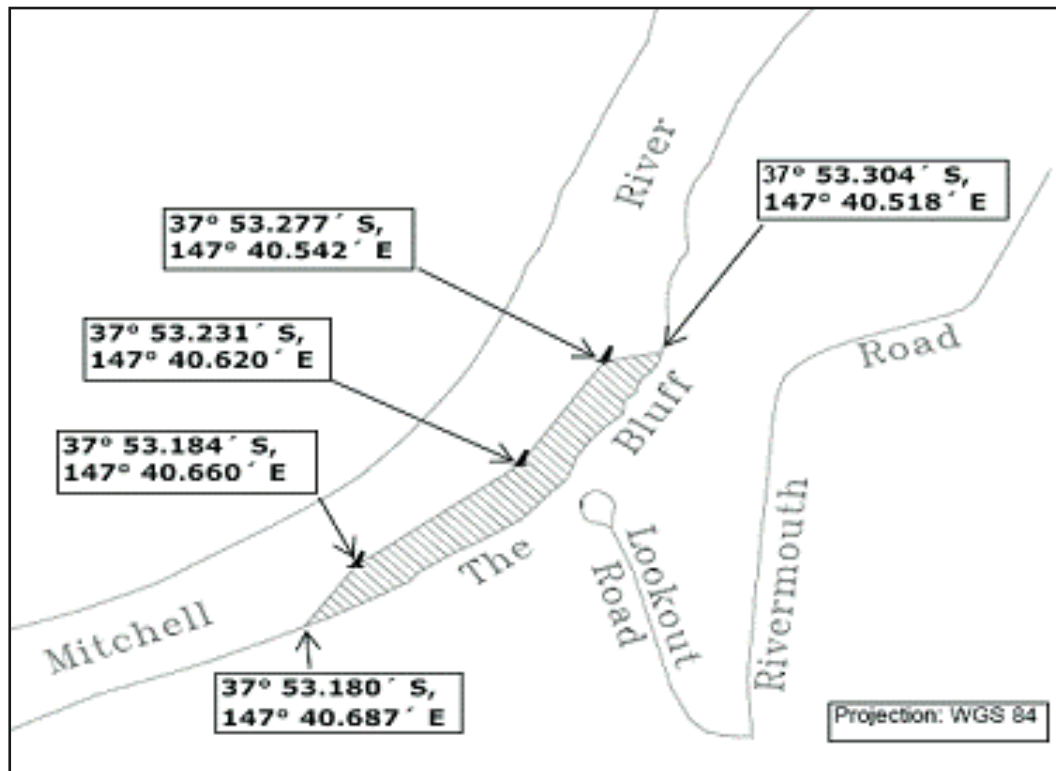

## SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Captain Rob Anderson, Harbour Master, Gippsland Ports, hereby give notice under subsection 15(1) of the **Marine Act 1988** that in the locations outlined below and until further notice, the operation of vessels (including anchoring, mooring or allowing a vessel to lie), is prohibited on the following waters of the Mitchell River:

- (a) The waters of Mitchell River within the area detailed in Table 1 and outlined on the map below.

Table 1: Mitchell River Exclusion Zone

The waters bounded by:

- (a) A line extending from a point on the shore located in approximate position  $37^{\circ} 53.304' \text{ S}$ ,  $147^{\circ} 40.518' \text{ E}$  to a marker buoy located in approximate position  $37^{\circ} 53.277' \text{ S}$ ,  $147^{\circ} 40.542' \text{ E}$ ;
- (b) A line extending from a marker buoy located in approximate position  $37^{\circ} 53.277' \text{ S}$ ,  $147^{\circ} 40.542' \text{ E}$  to a marker buoy in approximate position  $37^{\circ} 53.231' \text{ S}$ ,  $147^{\circ} 40.620' \text{ E}$ ;
- (c) A line extending from a marker buoy located in approximate position  $37^{\circ} 53.231' \text{ S}$ ,  $147^{\circ} 40.620' \text{ E}$  to a marker buoy in approximate position  $37^{\circ} 53.184' \text{ S}$ ,  $147^{\circ} 40.660' \text{ E}$ ;
- (d) A line extending from a marker buoy located in approximate position  $37^{\circ} 53.184' \text{ S}$ ,  $147^{\circ} 40.660' \text{ E}$  to a point on the shore in approximate position  $37^{\circ} 53.180' \text{ S}$ ,  $147^{\circ} 40.687' \text{ E}$ .
