VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues the part of the road described in Schedule B and on the plan attached and approves the sale of the surplus land as provided in section 47 of the **Transport Act 1983** and as delegated by the Minister for Roads and Ports under section 32 of the latter said Act.

#### SCHEDULE A

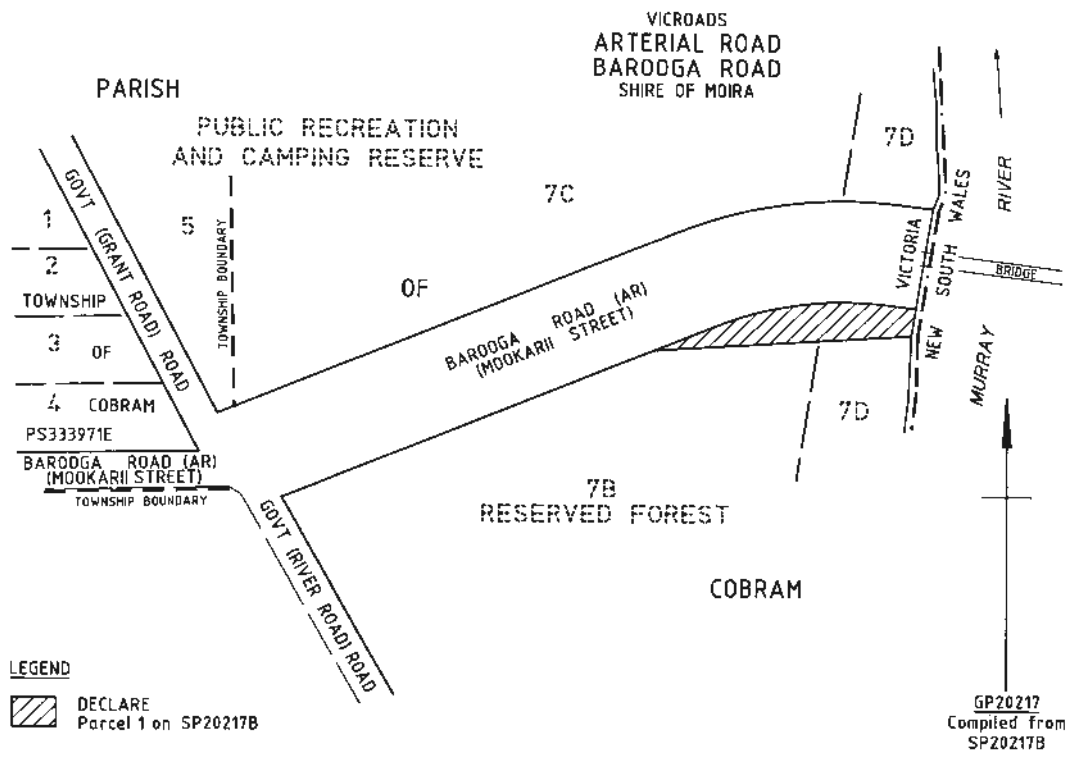
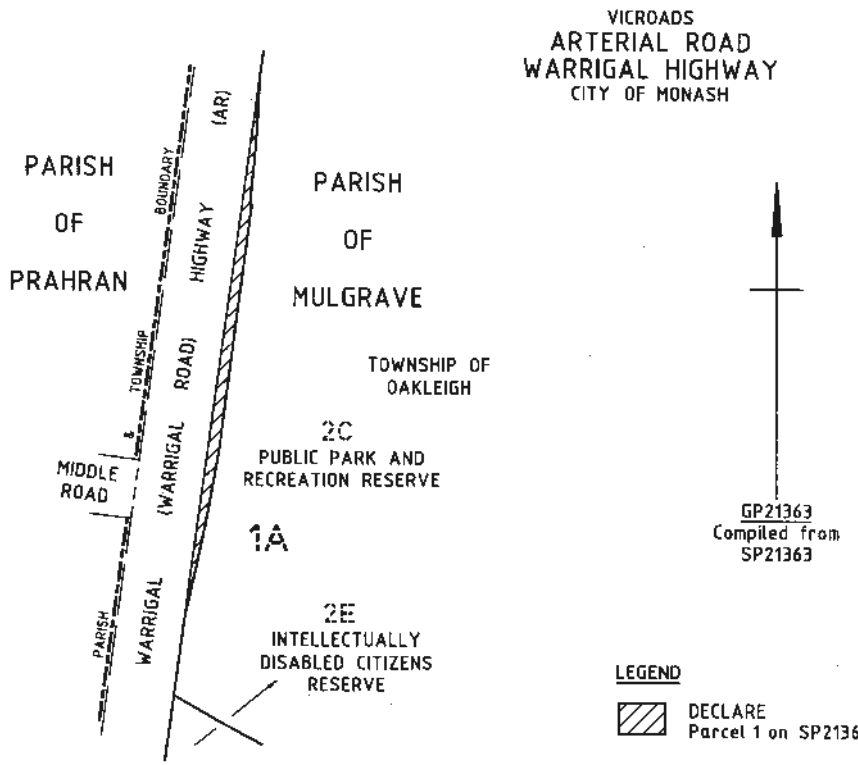
##### ARTERIAL ROAD

- c) That part of Keilor–Laverton Road identified by hatching on the plan numbered GP21301A is revoked as described in the legend in the said plan.

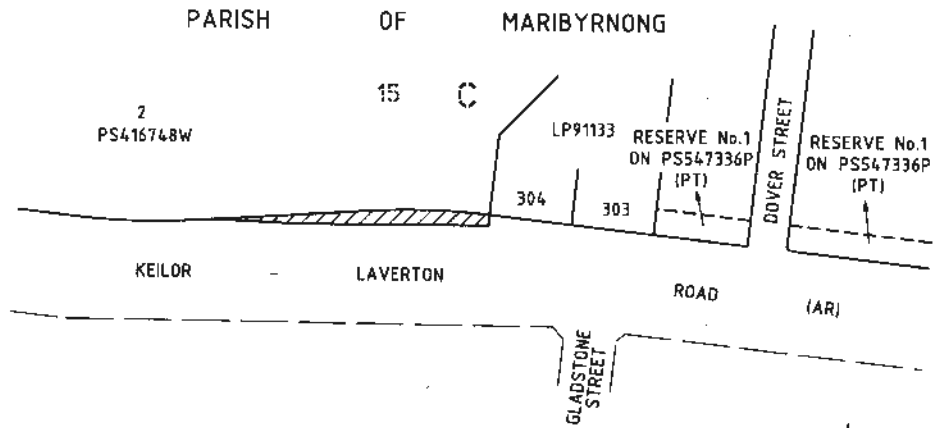
#### SCHEDULE B
