
## Road Management Act 2004

### ORDER PURSUANT TO CLAUSES 32 AND 33(7) OF SCHEDULE 5A

#### Order in Council

The Governor in Council, under clause 32 of Schedule 5A to the **Road Management Act 2004** (the Act), revokes the Order in Council of 13 October 1873 and referred to, pursuant to notice given in Government Gazette 19 September 1873 and that part of Crown grant entered on the Register Book, Vol 1902 Fol 380326 by the Registrar of Titles insofar as it relates to the Crown land (the Reserved Crown Land), located in the Redevelopment Project area (as defined in the Act) and identified as parcels 2 and 4 in the attached Survey Plan SP 21374.

Pursuant to clause 33(7) of Schedule 5A to the Act, the Reserved Crown Land is hereby reserved for the purposes of the Link Upgrade Project.



This order takes effect from the date it is published in the Government Gazette.


### Road Management Act 2004

#### ORDER PURSUANT TO CLAUSES 27 AND 28 OF SCHEDULE 5A

##### Order in Council

The Governor in Council, under clause 27 of Schedule 5A to the **Road Management Act 2004** (the Act), declares that all interests in the land located in the Redevelopment Project Area and identified as parcel 3 in the attached Survey Plan SP 21374 (the Subject Crown Land), are surrendered to the Crown.

Pursuant to clause 28(5) of Schedule 5A to the Act, this Order has the effect of reserving the Subject Crown Land for the purposes of the Link Upgrade Project.
