## SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Timothy Tully, a member of Victoria Police hereby give notice under subsection 15(2) of the **Marine Act 1988** that from 7.00 am on Saturday 18 October 2008 until 6.00 pm on Saturday 18 October 2008, surf boards and vessels involved in the Stand Up Paddleboard Rally at Torquay are exempt from the provisions of Clause 4(b) contained within Schedule 11 of Notice No.1 under section 15(2) of the **Marine Act 1988**.

## SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Steve Crawcour, Group Manager, Strategic and Community Development, Shire of Strathbogie, hereby give notice under subsection 15(1) of the **Marine Act 1988**, that:

The operation of vessels is prohibited on the waters of the Goulburn River from the upstream boundary of the 5 knot speed restriction zone adjacent to Tahbilk Winery, to the Scour Creek Bridge (adjacent to the Nagambie Lakes Leisure Park) and on Lake Nagambie within Willow Cove (east of the Scour Creek Bridge) and Furlong Cove (adjacent to the rowing compound) between the hours of 8.00 am and 1.00 pm on Saturday 11 October 2008 excluding –

- (i) vessels participating in The Head of the Goulburn Rowing Event or involved with management and safety; and
- (ii) vessels operated by the Shire of Strathbogie.

At the completion of the event or as determined and announced by the Shire's Group Manager, Strategic and Community Development, authorised by the Strathbogie Shire Council, the waters will revert to the provisions of Schedule 91 contained in Notice No.1 made under subsection 15(2) of the **Marine Act 1988**.
