NOTICE OF MINISTERIAL DIRECTIONS TO THE VICTORIAN COMMISSION FOR GAMBLING REGULATION IN RELATION TO SELF-EXCLUSION PROGRAMS AND RESPONSIBLE GAMBLING CODES OF CONDUCT

On 30 September 2008 the Minister for Gaming gave Directions to the Commission –

1. to ensure that a Self-Exclusion Program approved by the Commission meets the standards and requirements set out in the Direction; and
to ensure that regard is had to the guidelines in the Direction when determining whether a Self-Exclusion Program meets those standards and requirements; and
2. to ensure that a Responsible Gambling Code of Conduct approved by the Commission meets the standards and requirements set out in the Direction; and
to ensure that regard is had to the guidelines in the Direction when determining whether a Code of Conduct meets those standards and requirements.

The legislation is expected to commence on 1 December 2008 and gaming providers will have a further 6 months to have their Self-Exclusion Programs and Responsible Gambling Codes of Conduct approved by the Commission.
