ADDENDUM TO THE NOTICE CALLING FOR REGISTRATIONS OF INTEREST IN THE GRANT OF A KENO LICENCE UNDER THE **GAMBLING REGULATION ACT 2003 (VIC.)** MADE ON 17 SEPTEMBER 2008

This addendum is made pursuant to Part A, section 4.4 of the Notice (Additions and Amendments to Notice) which states 'The Minister reserves the right to change any information in, or to issue addenda to, this Notice. All such addenda will, upon issue, become part of this Notice. Any amendment to this Notice made on or before expiration of the Lodgement Period will be notified to potential Registrants via publication in the Victoria Government Gazette and a posting on the Victorian Government tenders website.'

The Minister, by issuing this Addendum to the Notice Calling for Registrations of Interest in the Grant of a Keno Licence (Notice), amends the evaluation criteria set out in Part B – section 1.1 of the Notice, by providing that:

Notwithstanding anything in the Notice to the contrary, the criterion against which the ROI (but not any subsequent invitation to apply for a Keno Licence) will be evaluated is whether there are reasonable grounds for believing that the Registrant will have the capacity and capability of satisfying the Minister in respect of the matters specified in Part B – section 1.1 of the Notice, rather than whether the Minister is satisfied as to those matters. Also, the Minister may form the view that it is in the public interest to limit the number of Registrants to be invited to apply for a Keno Licence. In that event, the Minister's decision as to which of the Registrants should be invited may be informed, among other things, by a consideration of the Registrants most likely to meet the requirements and criteria for the grant of a Keno Licence.

This Addendum does not require the provision of additional information in ROI submissions and therefore the Lodgement Period as stated in the Notice remains unchanged.

Except for the above, the Notice is not amended in any way.
