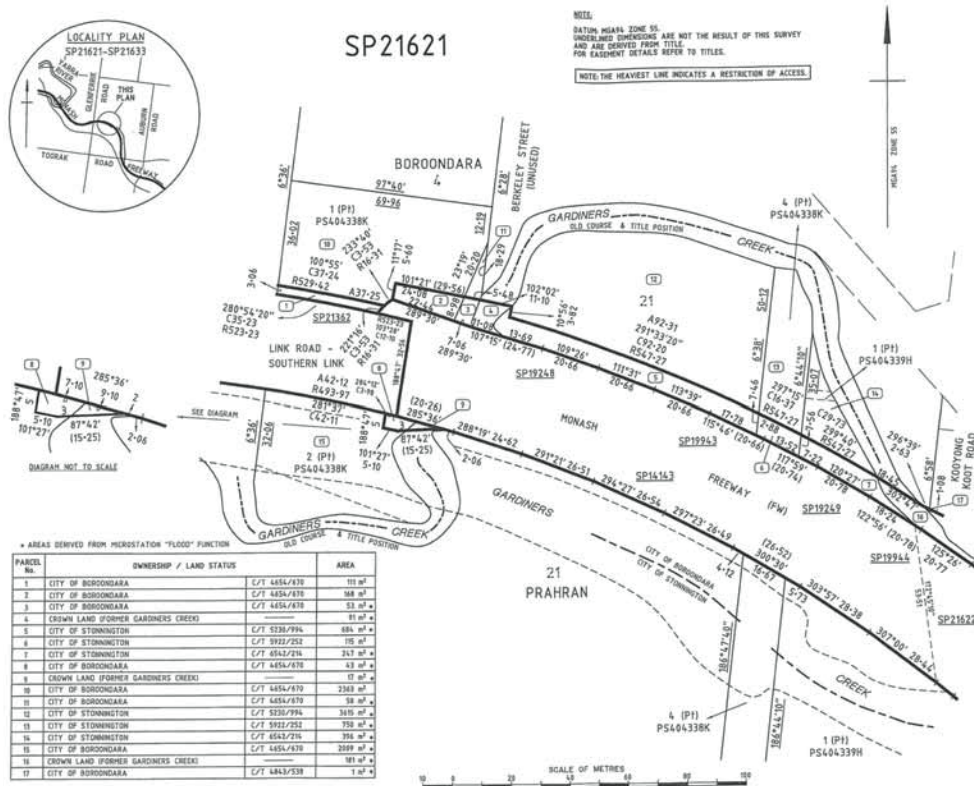
ORDER PURSUANT TO CLAUSE 26(1)(B) OF SCHEDULE 5A

Order in Council

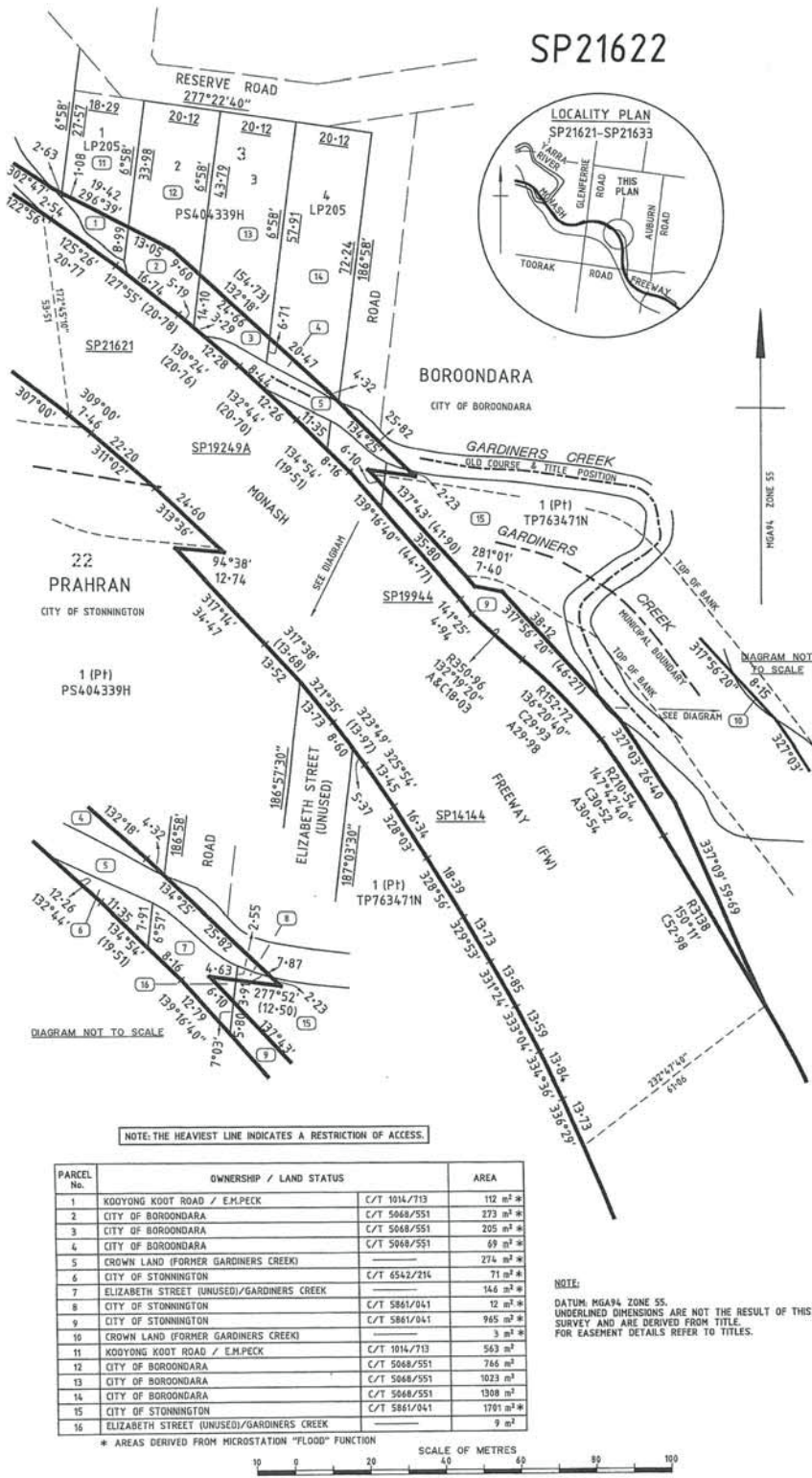
The Governor in Council, under clause 26(1)(b) of Schedule 5A to the **Road Management Act 2004** (the Act), divests from Bororoondara City Council and Stonnington City Council the land located in the Redevelopment Project area and identified as:

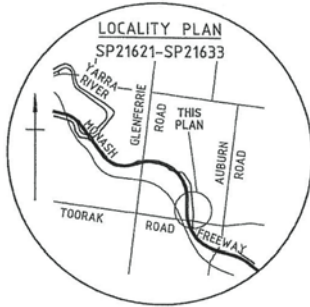
