Marine Act 1988

SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Chris Hardman, Manager of Operations, Bays and Marine Division, Parks Victoria, hereby give notice under subsection 15(1) of the **Marine Act 1988**, that between the hours of 11.00 am and 5.00 pm on Saturday 29 November 2008, the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding those vessels involved with the Head of the Yarra is prohibited on the waters of the Yarra River between, an imaginary line from the downstream edge of the VRA Landing to the upstream edge of Federation Wharf, and extending upstream to the Victoria Street Bridge.

- (a) vessels involved with the Head of the Yarra are excluded from Clauses 2(a), 3(a), 7 and 12 of Notice No. 1 made under s.15(2) of the **Marine Act 1988** between the hours of 11.00 am and 5.00 pm on Saturday 29 November 2008.
- (b) all operators and occupants of mechanically powered vessels operated by Life Saving Victoria, and involved in the event, are required to wear PFDs (Type 1, 2 or 3) and carry approved communications radio able to communicate with event organisers.
- (c) all rescue vessels, excluding PWCs, are required to carry 4 additional PFDs (Type 1, 2 or 3).
- (d) at the completion of the event and as determined and announced by Parks Victoria, the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.

I, the Director of Marine Safety, on the recommendation of Darren Schultz, Building and Contracts Officer, Loddon Shire Council, hereby give notice under subsection 15(1) of the **Marine Act 1988**, that:

- (a) from 4.00 pm Friday 5 December 2008 till 9.00 pm Sunday 7 December 2008, the waters of the Loddon River at Bridgewater, between the Flour Mill Weir and Sweenys Lane are subject to a speed restriction of 5 knots for the purposes of conducting the Loddon Classic Fishing Competition;
- (b) at the completion of the event the waters will revert to the provisions of Schedule 62 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.
