NOTICE OF ORDER

Order Declaring a Control Area for the Purposes of Ruminants that have Consumed Restricted Animal Material and for Sheep and Goat Identification

I, Joe Helper, Minister for Agriculture, give notice of an Order under section 29 of the **Livestock Disease Control Act 1994**, declaring the State of Victoria to be a control area in respect of the exotic disease Spongiform Encephalopathies and specifying the requirements which are to operate in the control area for ruminants that have consumed Restricted Animal Material (RAM) and for sheep and goat identification.

The Order provides for the identification of ruminants that have consumed RAM and for the notification of information regarding ruminants that have consumed RAM to the purchaser, to a livestock inspector, to PrimeSafe and to the Australian Quarantine Inspection Service. The Order also provides for the identification of sheep and goats before they are dispatched to another property or saleyard or to an abattoir. It also requires the provision of a National Vendor Declaration for any sheep or goats that are to be consigned to another property, saleyard or abattoir.

The Order has effect for twelve months from 21 November 2008 unless revoked earlier or continued for any further period or periods.
