### **ADDENDUM TO THE NOTICE CALLING FOR REGISTRATIONS OF INTEREST IN THE GRANT OF A KENO LICENCE UNDER THE GAMBLING REGULATION ACT 2003 (VIC.) MADE ON 17 SEPTEMBER 2008.**

This addendum is made pursuant to Part A, section 4.4 of the Notice (Additions and Amendments to Notice) which states 'The Minister reserves the right to change any information in, or to issue addenda to, this Notice. All such addenda will, upon issue, become part of this Notice. Any amendment to this Notice made on or before expiration of the Lodgement Period will be notified to potential Registrants via publication in the Victoria Government Gazette and a posting on the Victorian Government tenders website.'

The State confirms that Registrants should submit the information required by Part C, section 2.2 Schedule F items 6 and 9 of the Notice (which is accurate and complete in relation to those individuals who hold more than 5% of the shares in the Registrant and individuals who have beneficial ownership of 5% or more of the shares of the Registrant) as at 5 November 2008. Registrants should then update the VCGR with any changes to that information every time a notice of such change is given to the stock exchange of the applicable jurisdiction.

Except for the above, the Notice is not amended in any way.
