





- (k) any category 5 areas identified by ' on the attached Dog Controls Beaches Map 1, and the insert of the Geelong Waterfront Precinct map together with the area identified by ' on the Dog Controls Barwon River Map 2 (refer attached Maps 1 and 2).
- 2. All dogs that enter in or on the following public places must be restrained at all times by means of a chain, cord or leash, not exceeding two (2) metres in length between the hours of 10.00 am and 8.00 pm (during daylight savings times) and between the hours of 10.00 am and 6.00 pm (at all other times):
 - any category 2 areas identified by ' on the attached Dog Controls Beaches Map 1 (except any area managed by another land authority).
- 3. All dogs are permitted Off Leash in the following designated areas:
 - any category 1 areas identified by 'LL' on the attached Dog Controls Beaches Map 1; and 'ZZ' on Dog Controls Barwon River Map 2.
- 4. All dogs are prohibited from entering in or on the following public places at all times:
 - (a) rivers, creeks and other water bodies (except any beach designated and signposted as a swimming area for dogs); and
 - (b) any category 4 areas identified by '••••' on the attached Dog Controls Beaches Map 1 map (except any area managed by another land authority).

- 5. A night curfew is imposed for cats commencing on 1 July 2009. All cats must be securely confined to the owner's premises between sunset and sunrise each day.
- 6. Reference made to other land authorities in Dog Controls Beaches Map 1 will be subject to separate control orders.





Local Law No. 4 – Environment (Amendment No. 3) 2008

Notice is hereby given pursuant to section 119(3) of the **Local Government Act 1989**, that, at its meeting on 15 December 2008, the Loddon Shire Council resolved to make Local Law No. 4 – Environment (Amendment No. 3) 2008

The purpose of this Local Law is to provide a safe and healthy environment by prohibiting, regulating and controlling activities that may be dangerous to life or detrimental to the amenity of an area.

The proposed amendment includes significant increases in fines for those persons who do not act on Council's direction to clean up properties that are deemed 'untidy' or 'unsightly'.

Other changes are:

- introduction of a definition of a poultry house;
- introduction of a definition of a scare gun;
- amendment to Clause 7 to include 'untidy' properties;
- amendment to Clause 11 to include vehicles causing a nuisance;
- revocation of Clause 12 and replacement with provisions for the use of 'scare guns' and 'electronic speaker devices';
- provision for the issue of Temporary Dwelling permits in Clause 16;
- inclusion of 'bees' in Clause 19;
- amendment to Clause 23 to require that rubbish bins be of a type approved by Council: and
- amendment to Penalties whereby dollar amounts are replaced with penalty units.

The Cardinia Council has prepared Amendment C111 to the Cardinia Planning Scheme.

In accordance with section 8A(3) of the **Planning and Environment Act 1987**, the Minister for Planning authorised the Cardinia Council as planning authority to prepare the Amendment.

The Maribyrnong City Council has prepared Amendment C63 to the Maribyrnong Planning Scheme.

In accordance with section 8A(3) of the **Planning and Environment Act 1987**, the Minister for Planning authorised the Maribyrnong City Council as planning authority to prepare the Amendment.

The Amendment applies to the Bradmill Precinct at 355–359, 361–367 and 371–383 Francis Street, Yarraville West. The land is bound by Francis Street to the north, McIvor Reserve to the east and the Newport Goods Rail Line to the south-west.

The Amendment proposes to:

- rezone the land from part Industrial 1 Zone and part Industrial 3 Zone to part Residential 1 Zone and part Business 1 Zone;
- amend the Business 1 Zone Schedule;
- introduce a Development Plan Overlay (Schedule 7);
- introduce an Environmental Audit Overlay; and
- introduce changes to Clauses 21.02, 21.03 and 21.04 of the Maribyrnong Planning Scheme.

- Previous applications to VCAT have been approved for similar roles in the Royal Botanic Gardens in Melbourne (A133–2002, A33–2005, A203–2006, A79–2006, A2–2008) and the Royal Botanic Gardens in Cranbourne (A293–2008).

- The holder of this position will assist the applicant to develop culturally appropriate support systems, to develop strong working relationships with ATSI communities and agencies, and will assist in providing cultural awareness, education, training and support for the applicant's workforce.

GUIDELINES TO CALCULATE ANNUAL SOLAR ENERGY SAVINGS FOR DOMESTIC SOLAR WATER HEATERS PRODUCED BY ADDING A RETROFIT KIT (COLLECTORS AND PUMP) TO AN EXISTING TANK

Version 5.1 updated October 2008

Annual Solar Energy Savings Calculation Methodology for Domestic Solar Water Heaters

RETROFIT DOMESTIC SOLAR WATER HEATER MODELS

To determine the annual solar energy savings for a solar water heater retrofit kit not listed on Sustainability Victoria's list of kits approved for rebate, use the following methodology:

1. OVERVIEW

Modelling shall be conducted in the same manner as for a complete packaged solar water heating system as specified in the document 'Guideline to calculate annual solar energy savings for domestic solar water heaters rebate' available on the Sustainability Victoria website. As there is no tank included as part of the retrofit kit, a generic tank model shall be used for the modelling of annual solar energy savings.

Modelling shall be conducted to AS4234 using the TRNSYS program or extensions of the software in the TRNSYS modelling package, to determine the relative solar fraction in Southern Victoria (Zone 4). The results should be reported on the same spreadsheet as for the full system modelling.

The characteristics of the components to be used in the model are specified below.

2. COLLECTOR AREA

In order to limit the possibility of overheating in high solar conditions the maximum collector aperture area allowed in any retrofit kit is given below:

	Flat plate collectors	Evacuated tube collectors	
200 – 300 litres	2 m ²	1.5 m ²	
300 – 440 litres	4 m ²	2.5 m^2

3. COLLECTOR CHARACTERISTICS

The annual performance calculation shall use the actual performance and area of collectors in the model including:

- the collector performance measured to AS 2535.1 requirements (or equivalent eg ISO 9806–3);
- the number of collectors as defined in the kit specification; and
- the measured aperture area of each collector (or the area consistent with the collector performance curve characteristic if not the aperture area).

4. PUMP AND CONTROLLER CHARACTERISTICS

The model shall use the actual measured performance of the pump and the controller in the model, including:

- pump controller differential temperature settings for both switch on and switch off conditions and any other controller functions;
- maximum temperature at bottom of tank allowed by the controller to avoid overheating in the tank;

- pump flow rate, measured in pumping the collector fluid through a circuit configured consistent with the pipe lengths given in the plumbing between tank and solar collector table below; and
- pump power measured in the above configuration.

GUIDELINES TO CALCULATE ANNUAL SOLAR ENERGY SAVINGS FOR DOMESTIC SOLAR WATER HEATERS PRODUCED BY ADDING A SOLAR PREHEATER TO AN EXISTING GAS HOT WATER SYSTEM

Version 2.3 updated October 2008

Annual Solar Energy Savings Calculation Methodology for Domestic Solar Water Heaters

To determine the annual solar energy savings for a solar water preheater for inclusion on Sustainability Victoria's list of preheaters approved for a rebate, use the following methodology:

1. OVERVIEW

Modelling shall be conducted in the same manner as for a complete packaged solar water heating system as specified in the General Guidelines document 'Guideline to calculate annual solar savings for domestic SWH' available on the Sustainability Victoria website, with modifications as outlined in this guideline.

As there is no conventional heat source included as part of the pre-heater, a generic gas storage water heater (post heater) shall be included for the modelling of Annual Energy Savings.

Modelling shall be conducted to AS4234 using the TRNSYS program or extensions of the software in the TRNSYS modelling package, to determine the relative solar fraction in Southern Victoria (Zone 4). The characteristics of the components to be used in the model are specified below.

2. POST HEATER CHARACTERISTICS

The characteristics of the heater are defined in the table below.
