Crown Land (Reserves) Act 1978

INCORPORATION OF COMMITTEE OF MANAGEMENT AND APPOINTMENT OF CHAIRMAN

Order in Council

The Governor in Council, under section 14A(1) of the **Crown Land (Reserves) Act 1978**, being satisfied that it is in the public interest to declare to be a corporation the committee of management appointed under section 14(2) of the Act of the lands described in Column 1 hereunder:—

- (a) declares that the committee of management shall be a corporation;
- (b) assign the name shown in Column 2 to the corporation; and

under section 14B(3) of the Act, appoints the person listed in Column 3 to be Chairman of the corporation.
