SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Chris Hardman, Manager of Operations, Bays and Marine Division, Parks Victoria, hereby give notice under subsection 15(1) of the **Marine Act 1988**, that;

- (a) between the hours of 8.00 am and 3.30 pm on Sunday 7 December 2008, the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding those vessels involved with the 2008 Docklands Cup, Dragon Boat event is prohibited on the following waters of the Yarra River within the area detailed below in Table 1

Table 1: Victoria Harbour Exclusion Zone

The waters bounded by:

- (i) A line extending from a marker buoy located in approximate position 37°49' 4.51 S, 144° 56' 32.55 E to a marker buoy located in approximate position 37° 49' 1.67 S, 144° 56' 39.98 E;
- (ii) A line extending from a marker buoy located in approximate position 37° 49' 1.67 S, 144° 56' 39.98 E to a marker buoy in approximate position 37° 49' 3.71 S, 144° 56' 41.34 E;
- (iii) A line extending from a marker buoy located in approximate position 37° 49' 3.71 S, 144° 56' 41.34 E to a marker buoy in approximate position 37° 49' 6.61 S, 144° 56' 33.76 E;
- (iv) A line extending from a marker buoy located in approximate position 37° 49' 6.61 S, 144° 56' 33.76 E to a marker buoy in approximate position. 37°49' 4.51 S, 144° 56' 32.55 E.

- (b) at the completion of the event and/or as determined and announced by Parks Victoria, the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.

I, the Director of Marine Safety, on the recommendation of Chris Hardman, Regional Manager of Operations, Bays and Maritime Division, Parks Victoria, hereby give notice under subsection 15(1) of the **Marine Act 1988** that from 8.15 pm on Saturday 6 December 2008 till 10.30 pm on Saturday 6 December 2008, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the fireworks event and vessels owned and operated by Parks Victoria is prohibited within 200 metres of the fireworks barge located approximately 300 metres offshore from The Royal Geelong Yacht Club.
