VICTORIA PLANNING PROVISIONS
Notice of Approval of Amendment
Amendment VC46

The Minister for Planning has approved Amendment VC46 to the Victoria Planning Provisions (VPP) and all planning schemes in Victoria.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment changes the VPP and all planning schemes by modifying the following clauses to provide an exemption for strategic fuelbreaks of up to 40 metres width:

- Clause 42.01 – Environmental Significance Overlay (ESO)
- Clause 42.02 – Vegetation Protection Overlay (VPO)
- Clause 42.03 – Significant Landscape Overlay (SLO)
- Clause 44.01 – Erosion Management Overlay (EMO)
- Clause 44.02 – Salinity Management Overlay (SMO)
- Clause 52.17 – Native Vegetation

The exemption is to be subject to an appropriate Strategic Fuelbreak Plan being approved by the Secretary of the DSE.
