**Marine Act 1988**

## SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Stuart Ord, Regional Manager, City and Bays, Parks Victoria, hereby give notice under subsection 15(1) of the **Marine Act 1988** that from 4.00 pm Saturday 9 February to 1.00 pm Sunday 10 February the waters 270 metres seaward and situated from a point approximately 230 metres south of St Kilda Pier and extending to another point approximately 470 metres south of St Kilda Pier are exempt from the following clauses of Notice 1 made under section 15(2) of the **Marine Act 1988**:

- (a) Clause 9 as relating to point 4. (g) of Schedule 1 of Notice 1 made under section 15(2) of the **Marine Act 1988**; and
- (b) Clause 12 as relating to point 5. (b)(i) of Schedule 1 of Notice 1 made under section 15(2) of the **Marine Act 1988**; and
- (c) Clause 4(a) of Notice 1 made under section 15(2) of the **Marine Act 1988**; and
- (d) Clause 2(c) of Notice 1 made under section 15(2) of the **Marine Act 1988**;

for the dates and times detailed above.

The waters listed above are prohibited to all vessels and swimmers except those vessels involved in the regulation and presentation of the Personal Watercraft race event as part of the St Kilda Festival.
