## Road Safety Act 1986

### ROAD SAFETY (VEHICLES) REGULATIONS 1999

#### Class 2 Notice –

Specification of routes for B-double, Longer B-double,  
Controlled Access Bus, Vehicle Built to Carry Other Vehicles and  
Vehicles Built to Carry Livestock from Certain Dimension Limits

**1. Purpose**

To specify highways and routes that certain Class 2 vehicles from certain dimension limits may travel in or on.

**2. Authorising provision**

This Notice is made under Clauses 11, 37, 42 and 47 of Schedule 2 and regulation 510 of the Road Safety (Vehicles) Regulations 1999.

**3. Commencement**

This Notice comes into operation on the date of its publication in the Government Gazette.

**4. Expiration**

This Notice expires on 31 March 2008.

**5. Interpretation**

- (1) In this Notice, unless the contrary intention appears, expressions used have the same meaning as in the **Road Safety Act 1986** and the Road Safety (Vehicles) Regulations 1999.
- (2) For the avoidance of doubt, it is declared that nothing in this Notice is intended to authorise the driving of a vehicle in a manner or in a condition or place that is contrary to any law.

**6. Declaration**

By this Notice, the Roads Corporation specifies –

- Goulburn Valley Highway (Wyndham Street) between Dookie–Shepparton Road (Balaclava Road) and Knight Street in Shepparton;
- Knight Street between Goulburn Valley Highway (Wyndham Street) and Welsford Street in Shepparton;
- Welsford Street between Knight Street and Fryers Street in Shepparton; and
- Fryers Street between Welsford Street and Midland Highway in Shepparton;

as routes that

- B-double for the purpose of Clause 11;
- Longer B-double for the purpose of regulation 510;
- Controlled Access Bus for the purpose of Clause 37;
- Vehicles that are over 4.3 metres high, over 19.0 metres long and built to carry other vehicles for the purpose of Clause 42; and
- Vehicles that are over 4.3 metres high and built to carry livestock for the purpose of Clause 47;

may travel in or on.
