ROAD SAFETY (VEHICLES) REGULATIONS 1999

Class 1 Notice –

Specification of routes for Vehicles travelling under permit

1. Purpose

To specify highways and routes that Class 1 vehicles travelling under an oversize and overmass permit may travel in or on.

2. Authorising provision

This Notice is made under Clause 7 of Schedule 1 of the Road Safety (Vehicles) Regulations 1999.

3. Commencement

This Notice comes into operation on the date of its publication in the Government Gazette.

4. Expiration

This Notice expires on 31 March 2008.

5. Interpretation

- (1) In this Notice, unless the contrary intention appears, expressions used have the same meaning as in the **Road Safety Act 1986** and the Road Safety (Vehicles) Regulations 1999.
- (2) For the avoidance of doubt, it is declared that nothing in this Notice is intended to authorise the driving of a vehicle in a manner or in a condition or place that is contrary to any law.

6. Declaration

By this Notice, the Roads Corporation specifies –

- Goulburn Valley Highway (Wyndham Street) between Dookie–Shepparton Road (Balaclava Road) and Knight Street in Shepparton;
- Knight Street between Goulburn Valley Highway (Wyndham Street) and Welsford Street in Shepparton;
- Welsford Street between Knight Street and Fryers Street in Shepparton; and
- Fryers Street between Welsford Street and Midland Highway in Shepparton;

as routes that Class 1 Vehicles travelling under period permit may travel in or on.
