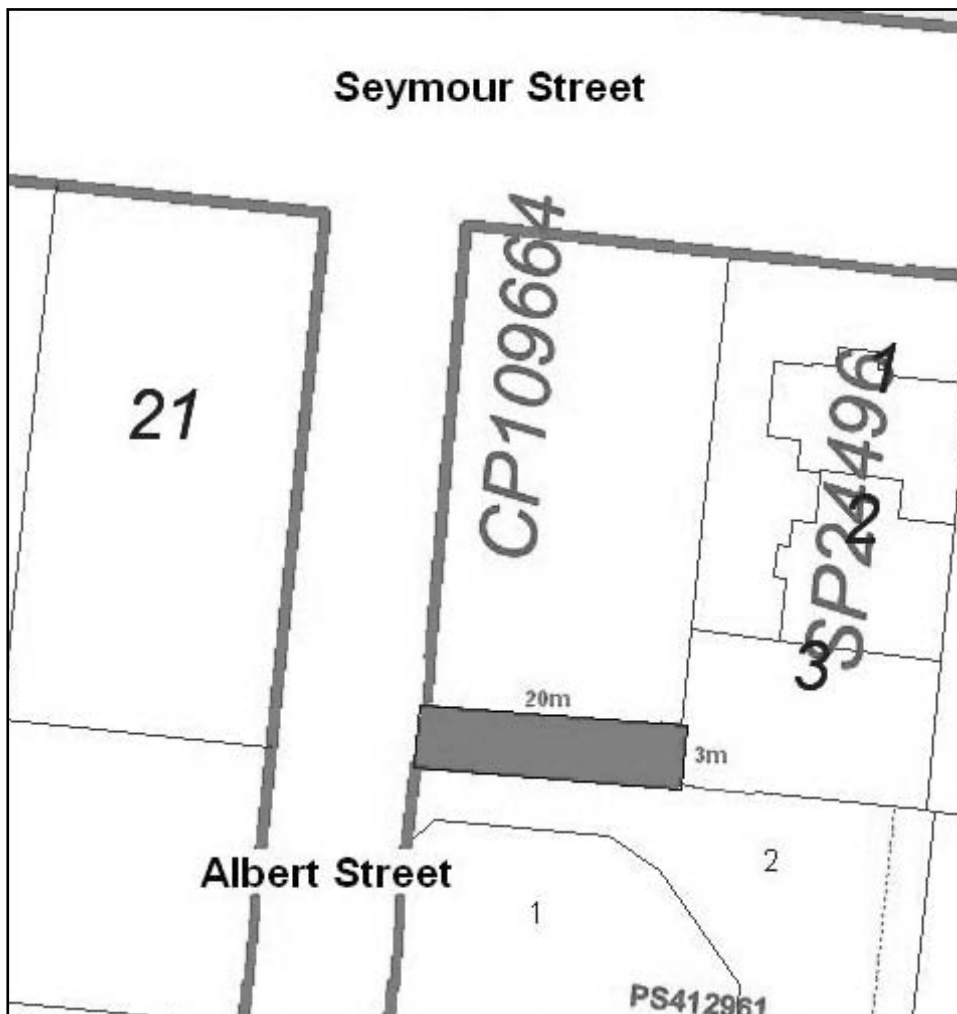

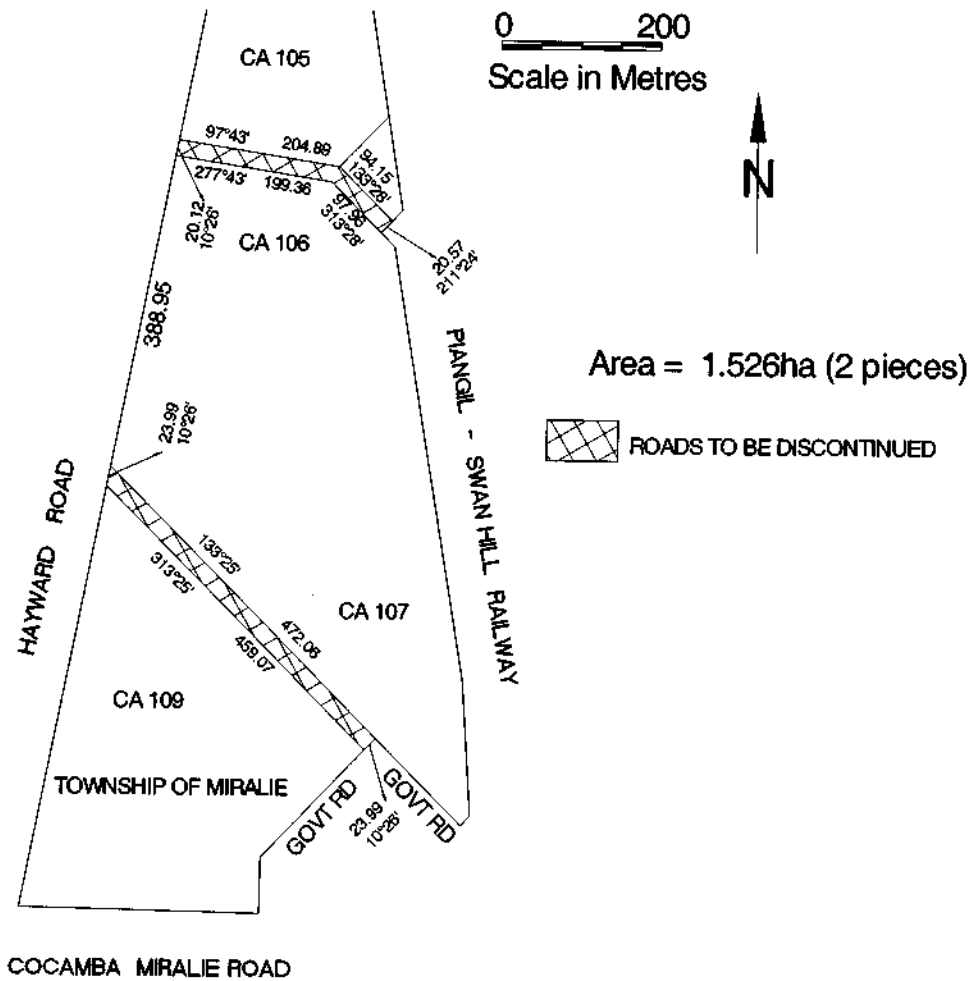

The Horsham Rural City Council has prepared Amendment C25 to the Horsham Planning Scheme.

In accordance with section 8A(3) of the **Planning and Environment Act 1987**, the Minister for Planning authorised the Horsham Rural City Council as planning authority to prepare the Amendment.

The land affected by the Amendment is described below:

- Land fronting Selkirk Drive, between Darlot Street and the adjacent residential area
- The Council depot in Selkirk Drive, Horsham
- Land fronting the south side of Wilson Street, between Darlot and Magee Court
- Land fronting the west side of Darlot Street, between Wilson Street and Selkirk Drive
- Land bounded by Madden Street, Baker Street, O'Callaghans Parade, and Hamilton Street
- Land fronting Stawell Road, generally south of the intersection with Golf Course Road
- Land fronting Plumpton Road, immediately west of Stawell Road
- Land surrounding the Horsham Airport.

The Amendment seeks to implement a number of recommendations from the Wimmera Industrial Land Capability Study by rezoning various parcels to Business 1 Zone, Business 2 Zone, Business 4 Zone, Residential 1 Zone, Residential 2 Zone, Industrial 3 Zone and Public Use Zone 6 – Local Government.
