Transport Act 1983

NOTICE OF SPECIFIED PLACES

I, Hector McKenzie, Director of Public Transport, under subsection (5) of section 158A of the **Transport Act 1983**, specify the following places for the purposes of that section –

1. Melbourne Airport.
2. Avalon Airport.
3. The Southern Cross Station Precinct in the City of Melbourne.
4. The Melbourne Casino Complex Area.
5. Station Pier in Port Melbourne.
6. The area of land bounded by Waterfront Place, Beach Street and Swallow Street in Port Melbourne, and the road related areas within 100 metres of that area.

In this notice –

‘Avalon Airport’ means –

- (a) the area of land bounded by Beach Road, Pousties Road, Gillets Road and Dandos Road in Avalon; and
- (b) any of the roads, or road related areas, within that area;

‘Melbourne Airport’ means –

- (a) Melbourne (Tullamarine) Airport declared as an airport site under the Commonwealth Airports Regulations 1997; and
- (b) inside all terminal buildings, the terminal frontage, forecourt areas and all airport car parks within that site; and
- (c) any of the roads, or road related areas, within 1 kilometre of Melbourne Airport;

‘Melbourne Casino Complex Area’ means –

- (a) the area of land bounded by the Yarra River, Clarendon Street, City Road and Queensbridge Street in the City of Melbourne; and
- (b) any of the roads, or road related areas, within 100 metres of that area;

‘road’ has the same meaning as in the **Road Safety Act 1986**;

‘road related area’ has the same meaning as in the **Road Safety Act 1986**;

‘Southern Cross Station Precinct’ means –

- (a) the area of land shown hatched on the plan in Schedule 2 to the **Rail Corporations Act 1996**; and
- (b) any roads, or road related areas, within 100 metres of that area;

‘Station Pier’ has the same meaning as Station Pier Land in the **Port Services Act 1995**.
